31.9 Performance Guarantee:

- 31.9.1 The successful tenderer is also required to submit Performance Bank Guarantee which shall be furnished within 30 days of issue of work order. In case the contractor fails to deposit performance guarantee within the stipulated period, no payment for the work done in respect of first running account bill will be released to the contractor. Moreover, interest @ 10% p.a. on performance guarantee amount would be levied (Non-refundable) for delayed period of submission of PBG. The performance guarantee shall be submitted in the form of irrevocable Bank guarantee to the extent of 5% (Five Percent) of total contract amount minus quoted amount against SOQ-5 as per format given as form "D" (**Appendix 63**) from a nationalized/Scheduled Bank (as per RBI schedule), having office in India along with undertaking as per Form "D1" (**Appendix 64**). The performance Bank Guarantee shall remain valid for 6 months beyond the scheduled date of completion/authorized extended period of completion (for the works covered under SOQ-1 to SOQ-4). If the agency fails to extend the validity of the performance guarantee, the same can be encased by AAI.
- 31.9.2 The Performance Bank Guarantee shall be accepted after due verification from the bankers of the tenderer.
- 31.9.3 No other form of Performance Guarantee other than the above shall be accepted.
