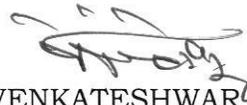

Corporate HRM Circular No. 17/2019

Sub: Recovery of Bond Amount on Resignation from AAI and Transfer & Acceptance of Bond

In supersession to all previous circulars issued in the said matter, the competent authority has decided the following w.r.t. Recovery of Bond Amount in case of Resignation from AAI and Transfer & Acceptance of Bond:

1.1 Levels and Disciplines: A bond may be taken at all Induction Levels i.e. from both Executives and Non-Executives in ATC, CNS and Fire-Discipline.

1.2 Recovery of Bond Amount in case of Resignation from AAI

(i) Bond Amount Recovery – for Executives

| Resignation During Training | | Resignation after training i.e. from the date of posting at station | |

| Beyond 01 month to 02 months | 2 lacs | Upto 1 year | 5 lacs |

(ii) Bond Amount Recovery – for Non-Executives

1.3 Transfer of Bond from AAI to other Organization: The bond will be transferable if the new organization (Central Govt./ State Govt. or Quasi Govt. or any other Public Enterprise) takes a fresh bond binding to serve for the balance of the original bond period. In case the official fails to serve the new department/organization, etc. or leaves it before completion of the original bond period for job where exemption from bond obligation is not available, the proportionate bond money should be released from the individual and refunded to AAI.

1.4 Acceptance of Bond from other Organization to AAI: AAI will accept bond from other organizations in all the disciplines subject to fulfillment of following conditions:

"To ensure that the requirement of obtaining a fresh bond from a person, where necessary, is fulfilled, the enterprise with whom the employee has executed the original bond may at the time of forwarding his application write to AAI under whom the employee intends to take up another appointment intimating AAI about the bond obligation of the individual and clarifying that in the case of his selection for the new post, his release will be subject to the condition that AAI takes from him a fresh bond, binding him to serve AAI for the balance of the original bond period and for the balance of the bond amount (balance bond amount of previous organization or AAI, whichever is higher); in case he fails to serve AAI or leaves it before completion of the original bond period for a job where exemption from bond obligation is not available, the proportionate bond money should be realized from the individual and refunded to the first organization with whom he originally executed the bond."

2. Further, it is clarified that as regards to counting of training period, the actual date of start of ab-initio training shall be considered for the purpose of calculation of recovery of bond amount on resignation.

3. The candidate will have to declare on selection about the organizations (Central Govt./ State Govt. or Quasi Govt. or any other Public Enterprise) in which he/she has applied at the time of joining and the application of the serving employees needs to be forwarded through proper channel.

4. The above will be effective from the date of issue of this circular.
