

***Ex Servicemen(ESM) Reservation :** The vacancy reserved for Ex-Servicemen(ESM) will be filled up from any category and then adjusted horizontally against respective categories viz., UR/SC/ST/OBC as the case may be, depending upon the category to which the selected candidate belongs to, that the vacancy earmarked for ESM is included within the respective total vacancies of the posts.

In Junior Assistant(Fire Service) post, there is no vacancy is available for ST category. however ST category candidates can apply for UR posts without claiming age relaxation and qualifying marks. (AGE should be *maximum* of 30 years and qualifying marks is 50% in Written exam)

****PWD Reservation :** Person With Disabilities(PWD) vacancies will be filled through horizontal reservation. **Post code 01 is not suitable/identified for PWD candidates.**
