Despite lapse of considerable and constant follow up by me the said differential gratuity has not been paid till date. Please quote specific orders for withholding the legitimate dues for such a long time.	There is no such specific order for withholding the dues has issued. However, the case for payment of difference of gratuity in r/o Ms. Veena Dhapse has already been submitted to the competent authority for perusal and approval and the same will be settled soon.
2	Please state the current position of proposal sent to MoLE in December 2024 in terms of para 10 of MoM dated 9 May 2024. Is the liability of MOCA/AAI to pay arrears of pension to all less than 10 years' retirees worked out by the department? If yes, what is the time limit by which date it is payable as per extant orders.	GM (HR)-Western Region/ CPIO, being the custodian of information may furnish reply to Point 2(Part 2) directly to the applicant under intimation to this office.
3	Please indicate the current position of REVISION OF MY PENSION as it is more than 8 years now from the date of my retirement in 2016. 7 CPC came into effect from January 2016. Revision in pension is must as and when pay revision is made as per guidelines of the Supreme Court.	The information has been sought from the concerned Authorities however necessary details have not yet been received. Once the information is received, AAI will compile the

4	Please intimate the total amount of arrears of pension and differential gratuity amount payable to me by the department vis a vis the amount of pension contribution due for refund from EPFO.	GM (HR)-Western Region/ CPIO, being the custodian of information may furnish reply w.r.t the details regarding the total amount of arrears of pension payable directly to the applicant under intimation to this office. The amount of differential gratuity amount comes to Rs. 3,31,913/- There is no such order issued by EPFO regarding refund of pension contribution.

3. In case you are not satisfied with the above reply, an appeal against this lies with ED (Admn.) and FAA, AAI, CHQ, A, Block, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003 within 30 days from the date of receipt of this letter.
