Sub: Assignment of duties of Department of Airport Systems

In order to streamline and expedite smooth procurement and maintenance of the Security equipment, the competent authority has approved that Deptt. of Airport Systems along with their sanctioned manpower, as per HR office order no. A.60011/19/2015/HRPC/192 dated 24.05.2017, to be brought under the purview of Member (Ops) with immediate effect.

2 As such, the reporting of Airport Systems officials shall be as under:

a. At CHQ:

- GM (Airport Systems) shall report to ED (Tech) for procurement and maintenance of AS systems
- Currently, the maintenance of AS systems is managed by GM (CNS-AS-O&M) along with CNS & AS officials. This responsibility will now be transferred to GM (AS).

b. At Regional Headquarters:

- Airport Systems In-charges shall report through the concerned GM (Engg-E) to RED. However, AS-In-Charge shall oversee the procurement and maintenance of AS systems at airports in their region.

c. At Kolkata & Chennai Airports: Airport Systems In-charges shall report to the respective Airport Directors.

d. Field Stations: At Present, very few stations are manned with AS manpower. Where Airport Systems officials are not available, Electrical Engineering Department will manage the Airport Systems works.

e. New Terminal Building and expansion of terminal building projects:

- At CHQ, the AS team of officers will continue coordinating all project works with the concerned Engineering Directorate for SoW, TS, Tender, and project management.
- At RHQ, AS-In-Charge shall look after all the project related works.
- At stations, project management is currently handled by Electrical Engineering with the assistance of CNS officer(s). Moving forward, Electrical Engineering will oversee all AS project works at stations. If required, they will seek help from Airport Systems officer posted in RHQ / CHQ depending upon the project size.

At present, CNS Dept. is looking after all the works of Airport Systems at RHQ and stations. Hence, suitable handing over taking over be completed within one month i.e. 31.08.2024.
