- d) TEMPO/SUV/MINIBUS : Rs. 70/-
- e) Car : Rs. 50/-
- f) Two wheeler : Rs 20/-

No entry fee is applicable for entering vehicle at Deoghar Airport except commercial vehicle.

**C) FACILITY NAME : Car Parking**

- 1) **Scope:** Vehicle Parking Management and Collection of Parking Fees
- 2) Computerized billing is to be ensured. Manual billing is not permitted.
- 3) The distribution of designated car parking for specific airport users may be reviewed and revised from time to time at the Airport Level on need basis by Airport Director.
- 4) **Access fee for all commercial vehicles entering at arrival area can be levied @ Rs. 30/- per vehicle.**
- 5) Schedule of Parking Charges:  
Parking fee will be charged from all vehicles entering the designated parking area, as detailed below:

- a. Rates as per existing slab will be applicable for upto 120 minutes, the same is also reproduced below:
