1. Item rate tenders are invited through the e-tendering portal by Asst. General Manager (Engg.-Elect), AAI, S.V. Airport, Raipur on behalf of Chairman, AAI, from eligible contractors for the work **“Annual Operation and Preventive Maintenance Job contract for E & M installations of Terminal Buildings and ancillary buildings/ installations Located on City Side at S.V. Airport, Raipur during 2018-20.”** at an estimated cost of **Rs. 2,70,29,510.00 (i/c GST)** with period of completion **24 (Twenty four) Months.**

The tendering process is online at e-portal URL address <https://etender.gov.in/eprocure/app> or www.aai.aero aspiring bidders may download and go through the tender document.

Prospective Tenderers are advised to get themselves register at CPP-portal, obtain 'Login ID' & 'Password' and go through the instructions available in the Home Page after log in to the CPP-portal <https://etender.gov.in/eprocure/app> or www.aai.aero. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. The process normally takes 03 days' time. Tender fee of **Rs. 1,180/- (i/c GST) Non-refundable** will be required to be paid offline in the form of Demand Draft in the name of "Airports Authority of India" payable at "Raipur" from Nationalized or any scheduled bank (but not from co-operative or Gramin bank). The original Demand Draft against Tender fee should reach by post/ courier/given in person to the concerned officials, within 3 days **of the last date of bid submission or as specified in the Tender Document**. The details of Demand Draft / any other accepted instruments, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time.

Envelope-I: - Containing qualifying requirements of Contractor / Firm: -

The tenderer shall submit their application only at CPP portal <https://etender.gov.in/eprocure/app>. Tenderer/Contractor are advised to follow the instruction provided in the tender document for online submission of bids. Tenders are required to upload the digitally signed file of scanned documents along with **scanned copy of Demand Draft for Tender Fee**. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered. Hard copy of application shall not be entertained.

Envelope-II: - Qualifying requirements of contractors/firms, EMD and unconditional acceptance of AAI's tender conditions

- i. Should have valid Registration on the Date of Submission of bid through e-portal in appropriate class of CPWD/ MES/ P&T/ Railways/ State PWD/ PSU/ Municipal Corporations & Development Authorities of Delhi, Mumbai, Chennai and Kolkata.

OR

Should have satisfactorily completed (# Phase / Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of **Rs. 54,05,902.00** or two works, each of **Rs. 67,57,378.00** or one work of **Rs. 1,08,11,804.00** of similar nature in single contract during last seven years ending on 31.01.2018 in India. **(Similar nature of work means "AMC of E&M installation or O&M of E&M installations")**

"The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rete of 7% per annum, calculated from the date of completion to the last date of submission of bid."

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Firms showing work experience certificate from nongovernment / non-PSU organizations should submit copy of tax deduction at sources certificate in support of their claim for having experience of stipulated value of work.

- ii. Should process valid electrical contractor license.
- iii. Shall have Permanent Account Number (PAN).
- iv. EPF Registration.
- v. ESI Registration.
- vi. GST Registration.
- vii. Should have annualized average financial turnover of **Rs 40,54,427.00** against works executed during last three years ending 31st March of the previous financial year. As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement duly signed by authorized signatories and counter signed by Chartered Accountant of the firm should be submitted along with the application. Firms showing continuous losses during the last three years in the balance sheet shall be summarily rejected.

Scanned copy of earnest money deposit (EMD) of value Rs. 5,40,590/- in the form of Demand Draft in the name of "Airports Authority of India" payable at "Raipur" as stipulated in the notice inviting tender may be submitted in "Tech Bid Folder" in Technical Bid/ Attachments section of e-tendering portal along with Unconditional Acceptance of AAI's Tender Conditions (Performa given in page no. 17 of Tender Document).

Envelope-III: - The Financial e-bid through CPP portal.

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the file name. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

3. Original EMD and hard copy of signed Unconditional Acceptance of AAI's Tender Conditions to be sent to the **O/o Asst. Gen. Manager (E-E), Airports Authority of India, S.V. Airport, Raipur-492015** and should reach to Bid Manager before the date & time mentioned in **CRITICAL DATE SHEET**. Tender of the tenderer whose EMD, unconditional acceptance of AAI's tender conditions and affidavit for payment of minimum wages are not received by the time of the opening of pre-qualification of tender then their tenders will be summarily rejected. Any postal delay will not be entertained.

4. Bids Opening Process is as below:-

Envelope-I: - Containing documents for pre-qualification bid (uploaded by the contractors/firms) shall be opened as per **CRITICAL DATE SHEET**. The intimation regarding acceptance/rejection of their bids will be intimated to the contractors/firms through CPP portal.

Envelope-II:- Technical bid opening date shall be as mentioned in **CRITICAL DATE SHEET**. (depending on pre-qualification, any changes in the date shall be intimated through CPP portal).

If any clarification is needed from the bidder about the deficiency in his uploaded documents in Envelope –I and Envelope-II, he will be asked to provide it through CPP Portal. The bidder shall upload the requisite clarification/ documents within time specified by AAI, failing which tender will be liable for rejection.

Envelope-III: - The financial bids of the contractors/ firms found to be meeting the qualifying requirements and technical criteria shall be **CRITICAL DATE SHEET**. (depending on Technical bid evaluation, the date shall be intimated through CPP portal).

5. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.

AAI reserves the right to disallow issue of tender document to working agencies whose performance at ongoing project(s) is below par and usually poor and has been issued letter of restrain / temporary / permanent debar by any department of AAI. AAI reserve the right to verify the credential submitted by the agency at any stage (before or after the award the work). If at any stage, any information / documents submitted by the applicant is found to be incorrect /false or have some discrepancy which disqualifies the firm then AAI shall take the following action:

- a) Forfeit the entire amount of EMD submitted by the firm.
- b) The agency shall be liable for debarment from tendering in AAI, apart from any other appropriate contractual /legal action.

6. Consortium /JV companies shall not be permitted. No single firm shall be permitted to submit two separate applications.
7. Purchase preference to Central Public Sector undertaking shall be applicable as per the directive of Govt. of India prevalent on the date of acceptance.
8. **Concessions to Indian Micro and Small Enterprises (MSE's) units will be given as per the provisions (Para-10) of public procurement policy for MSE's order 2012, MSE's (Micro and Small Enterprises) registered with DIC/NSIC/KVIC/KVIB/Directorate of Handicraft and Handloom etc.**
