**NOTICE INVITING QUOTATIONS (NIQ)**

**Subject: Notice Inviting Quotation for “Supply, Installation and Testing of HDD for CCTV Server at Civil Airport, Jammu”.**

Sealed quotations are hereby invited from the Suppliers/Authorised Dealers of IBM for “**Supply, Installation and Testing of HDD for CCTV Server at Civil Airport, Jammu**” as per the specifications mentioned in “Annexure 1” from the Airport Director, Airports Authority of India, Civil Airport, Jammu-180003 as per terms & conditions mentioned in this NIQ.

- i)** It is requested to quote the lowest offer price in the enclosed Schedule after satisfying the terms and conditions in this NIQ. The sealed master envelope containing both envelope “A” & “B” must bear inscription on the top of the cover “Supply, Installation and Testing of HDD for CCTV Server at Civil Airport, Jammu” and to be addressed to The Airport Director, AAI, Civil Airport, Jammu-180003. - ii) Envelope ‘A’ will contain Technical Bid**  
**Important: Each Quotation must contain following documents inside the Envelope ‘A’** duly signed on each page positively. Without any of the following documents, the Quotation will be rejected.
  - a) Duly signed copy of original NIQ document.
  - b) Acceptance letter- Annexure-A.
  - c) Copy of GST Registration Certificate.
  - d) Supplier/Authorized dealer should submit Authorization letter from IBM
  - e) Copy of PAN Card.
  - f) Duly signed Compliance Statement (Annexure 1)
  
- iii) Envelope ‘B’ will contain only Price-Bid (Annexure - ‘B’).**
  
- iv)** The Quotation must reach this office either by Speed Post/By Hand/by dropping in the Quotation Box (which will be available at The office of Airport director, AAI, Civil Airport, Jammu-180003) on or before 1400 IST of 19/01/2018. Quotations will be opened on the same day at 1500 IST. Initially the Envelope ‘A’ will be opened and after satisfying all the conditions, Envelope ‘B’ of the eligible bidders will be opened on 24/01/2018 at 1500 IST. For any further clarification

v) The Airport Director, AAI, Civil Airport, Jammu reserves the right to reject any or all the quotations without assigning any reason thereof.

**Terms & Conditions: -**

- i) The rates are to be inclusive of the taxes CGST, SGST and IGST, levies and charges. Grand total should be entered in figures as well as in words (No discrepancy). The validity of rate must be valid for minimum 30 days from the date of opening of the bids.
- ii) Work order as per requirement will be placed after accepting/satisfying the rate as Lowest, with proper specifications. No alteration of make/model is permitted once the offer is submitted.
- iii) Supplied items should be in good condition of packing and free from any defect. Brand, model and specifications will be strictly followed as per the schedule.
- iv) Any loss or damage to the item while handling/transporting till such time the items are delivered at its destination is the responsibility of supplier.
- v) Items shall contain warranty of one year from the date of testing/commissioning by the purchaser. If any damage/deterioration is found during warranty period, same is to be replaced/repared without any extra cost to the purchaser.
- vi) The rates once quoted shall be final and no escalation or deviation shall be accepted under any circumstances. Nothing is to be written on commercial/financial bids except rate and discount.
- vii) Work should be completed within the stipulated time of 10 days from the date of receiving of work order in the premises of Civil Airport, Jammu.
- viii) **Liquidity Clause: -**
  - (a) In case of failure to execute the order in full within the specified period, liquidated damages will be charged @ 1% per week, treating part of the week as a whole and up to a maximum of 10% of the total amount.
  - (b) If the delay in supply exceeds 2 weeks of the stipulated time frame, then AAI shall have the option to cancel the order.
- ix) **Payment:** -100% of payment shall be made after satisfactory supply/delivery of items in stipulated time and on production of two copies of Challan and three copies of Bill. **Submission of Complete Bank Details is mandatory for making e-payment (Online) through NEFT/RTGS.**
- x) **Arbitration:** - Except where otherwise provided for in the contract, all questions and disputes relating to the meaning of the specifications, designs and

instructions herein after mentioned and so the quality of workmanship or materials used in the work or as to any other question, claim, right, relating to the contract, designs, specifications, estimates, and instructions, orders of these conditions or otherwise concerning the works or their execution or failure to execute the same, whether arising during the progress of the work or after the completion or abandonment thereof, shall be referred to the sole arbitrator as may be appointed by the Airport Director, AAI, Civil Airport, Jammu-180003. It is the term of the contract that the party invoking arbitration shall specify the dispute or disputes to be referred to arbitration under this clause together with the amount or amounts claimed in respect of each such dispute. The arbitrator(s) may from time to time with the consent of the party, enlarge the time, for making and publishing the award. The supply of items under the contract shall, if reasonably possible, continue during the arbitration proceedings and no payment due or payable to the contractor shall be withheld on account of such proceedings. The arbitrator shall be deemed to have entered on the reference on the date he issues notices to both the parties fixing the date of the first hearing. The venue of arbitration shall be such place as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final, conclusive and binding on all parties to this contract.

xi) **Force Majeure Clause:** -

(a) Force majeure is here in defined as any cause which is beyond the control of the contractor or the purchaser as the case may be which could not be foreseen or with a reasonable amount of diligence could not have foreseen which substantially affect the performance of the contract such as Act of government including but not limited to war declared or undeclared, Priorities quarantines, embargoes, provided either party shall within fifteen days from the occurrence of such a cause, notify the other in writing of such cause.

(b) The contractor or the purchaser shall not be liable for delays in performing his obligations resulting from any force majeure clause as referred to and or defined above. The date of completion provided herein, will be extended by a reasonable time period.

xii) **Effect and legal Jurisdiction:** -The contract shall be considered as having come into force from the date of receiving of Supply Order by the purchaser.

xiii) The law applicable to this contract shall be the law enforced in the state of Jammu and Kashmir. The courts of Jammu shall have exclusive jurisdiction in all matters arising out of this contract.

xiv) AAI reserves the right to reject any or all quotation (s) in part or in full without assigning any reason.

xv) The Airport director, AAI, Civil Airport, Jammu-180003 is the competent authority.

xvi) Airport Entry Pass: Bidder has to take valid entry pass during work execution at his own cost.
