**Lakhs** in single contract of similar nature of works **i.e Any civil construction works involving Brick work/RCC work/civil maintenance and repair work** during last seven years ending last day of month previous to the one in which tenders are invited.

The details of similar works completed during last seven years in the given format- **Form-A** with supporting documents issued by client.

**Note:**

1. The Experience Certificates of works completed pre-GST era, Completion amount will be divided by 1.12 (to exclude pre-GST taxes) to make it at par with experience certificates of post GST era but excluding GST.
2. The Tenders invited for Annual Rate Contracts for O&M/ AMC/ CMC works, the works experience may be counted for the value of work for a completed one year on pro-rata basis to prequalify agency that has completed one year of AMC but work is still not completed due to longer period of AMC.
3. Experience gained by executing work on back-to-back contract/ Sub-contract basis is acceptable in the following conditions:
  - (a) Work should be actually executed by the second agency (sub-contractor) with due concurrence of the owner as tripartite agreement/ written approval. It should be backed by valid agreement and experience certificate.
  - (b) Payments received by second agency should be reflected in TDS certificates.
4. Experience gained in composite works for the specialized nature of works (List of Specialized Items / Jobs/ Works are mentioned at Para 35.3 of AAI Works Manual) were executed by main contractor either by in-house expertise & experience or by engaging the specialized agencies with the approval of main client as per contract conditions. In such cases, main contractor as well as specialized agency both get the experience certificate for the same work from their respective client(s) i.e. main contractor for composite work along with specialized works from owner and specialized agency for specialized work(s) from the main contractor.

In this situation, the experience certificate of either specialized agency or main agency having in-house expertise & experience, who has actually executed the specialized work(s), shall be considered for Technical /Pre-qualifying criteria in similar specialized nature of work(s).
5. Substantial completion shall be based on 80 (eighty) per cent (value wise) or more works completed under the contract. Substantial completion should not be defined in terms of percentage completion. rather it should be based on functional consideration. Certificate for 'substantial completion of project/work/asset should contain two parts. Part -1 shall contain 'financial value of work done' and part-11 shall contain 'certificate of functional completion of project/work/asset'.

**“The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to date of bid opening (Cover-I/ Technical bid).**



Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. **Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate(s) along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work with UDIN.**

- ii. Should have Average Annual Financial Turnover of **Rs. 10.62 Lakhs** on construction works during last three years ending 31st March of the previous financial year. The Financial Information shall be submitted in the given format – **Form-B with UDIN**. Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.
- iii. The tenderer should have a minimum net worth of **Rs. 4.50 Lakhs** issued by certified Chartered Accountants. The Certificate should be submitted in the given format- **Form-C with UDIN**.

#### **Envelope-II: - The Financial e-Bid through CPP portal.**

All rates shall be quoted in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the tenderers. Tenderers are required to download the BOQ file, open it and complete the blue coloured (unprotected) cells with their respective financial quotes and other details (such as name of the tenderer). No other cells should be changed. Once the details have been completed, the tenderer should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the tenderer, the bid will be rejected

#### **3. Refund of EMD**

EMD amount of the rejected bidders will be refunded to their source account after submission of Technical / Financial evaluation report on CPP portal by bid Manager

#### **4. Bid Submission: -**

Tenderer/Contractor are advised to follow the instructions provided in the tender document for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents as per Para 2. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

Uploading of application in location other than specified above shall not be considered.



**Hard copy of application shall not be entertained.**

5. Not more than one tender shall be submitted by one tenderer or tenderers having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
6. Tenderer who has downloaded the tender from Central Public Procurement Portal (CPPP) website <http://etenders.gov.in/eprocure/app>, shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AAI.

**7. Bids Opening Process is as below: -**

**Envelope-I (Technical bid and Pre-qualification):**

Envelope-I containing documents as per Para 2 (A) and (B) (uploaded by the tenderers) shall be opened on date & time mentioned in CRITICAL DATA SHEET.

If the bidder has any query related to the Bid Document of the work, they should use 'Seek Clarification' on CPP portal to seek clarifications. No other means of communication in this regards shall be entertained.

If any clarification is needed from the tenderer about the deficiency in his uploaded documents in Envelope – I, he will be asked to provide it through CPP portal, if required. The tenderer shall upload the requisite clarification/documents within time specified by AAI, failing which it shall be presumed that bidder does not have anything to submit and bid shall be evaluated accordingly.

The intimation regarding acceptance/rejection of their bids will be intimated to the tenderers through CPP portal.

**Envelope-II (Financial Bid):**

8. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI also reserves the right to call off tender process at any stage without assigning any reason.
9. AAI reserves the right to disallow the working agencies whose performance at ongoing project (s) is below par and usually poor and has been issued letter of restrain/Temporary or Permanent debarment/black listing by any department of



AAI or Central /State Govt. Depts./PSUs/World Bank/ ADB etc. **AAI reserves the right to verify the credential submitted by the tenderer at any stage (before or after the award the work). **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <http://etenders.gov.in/eprocure/app>.

**REGISTRATION**

1. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <http://etenders.gov.in/eprocure/app>) by clicking on the link “**Online Bidder Enrollment**” on the CPP Portal which is free of charge.
2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
3. Bidders are advised to register their valid email address and Mobile Numbers as part of the registration process. These would be used for any communication from the CPP Portal.
4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.

## CONDITIONS OF CONTRACT

### Definitions :

1.		The contract means the documents forming the tender and acceptance thereof and the formal agreement / agreements executed between the competent authority(s) on behalf of the Chairman, Airports Authority of India and the Contractor, together with the documents referred to therein including these conditions, the specifications, designs, drawings and instructions issued from time to time by the Engineer-in-Charge and all these documents taken together, shall be deemed to form one contract / two contracts and shall be complimentary to one another. Contractor has to sign two agreements, one consisting BOQ for Civil works and another one for SITC and O&M /AMC / AICMC part. Engineer-in charge could be common for both the agreements. Separate invoices for the civil /construction works and SITC / O&M / AICMC / AMC works have to be raised by the agency referring to the respective agreements to facilitate AAI to claim input tax credit on such SITC / O&M / AICMC / AMC works as mentioned in Schedule 'F' para 2(v).
2.		In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them :-

## AIRPORTS AUTHORITY OF INDIA

### SAFETY CODE

1. Suitable Scaffolds should be provided for workmen for all works that cannot safely be done from the ground, or from solid construction except such short period work as can be done safely from ladders. When a ladder is used, an extra mazdoor shall be engaged for holding the ladder and if the ladder is used for carrying materials as well suitable footholds and hand-hold shall be provided on the ladder and the ladder shall be given an inclination not steeper than  $\frac{1}{4}$  to 1 ( $\frac{1}{4}$  horizontal and 1 vertical).
2. Scaffolding of staging more than 3.6m (12ft.) above the ground or floor, swung or suspended from an overhead support or erected with stationary support shall have a guard rail properly attached or bolted, braced and otherwise secured at least 90 cm. (3ft.) high above the floor or platform of such scaffolding on staging and extending along the entire length of the outside and ends thereof with only such opening as may be necessary for the delivery of materials. Such scaffolding or staging shall be so fastened as to prevent it from swaying from the building or structure.
3. Working platforms, gangways and stairways should be so constructed that they should not sag unduly or unequally, and if the height of the platform or the gangway or the stairway is more than 3.6 m (12ft.) above ground level or floor level, they should be closely boarded, should have adequate width and should be suitably fastened as described in (2) above.
4. Every opening in the floor of a building or in a working platform shall be provided with suitable means to prevent the fall of person or materials by providing suitable fencing or railing whose minimum height shall be 90cm.(3ft.)
5. Safe means of access shall be provided to all working platforms and other working places. Every ladder shall be securely fixed. No portable single ladder shall be over 9m. (30ft.) in length while the width between side rails in rung ladder shall in no case be less than 29 cm. (11  $\frac{1}{2}$  ") for ladder upto and including 3m. (10ft.) in length. For long ladders, this width should be increased at least  $\frac{1}{4}$ " for each additional 30cm. (1 foot) of length. Uniform step spacing of not more than 30cm shall be kept. Adequate precautions shall be taken to prevent danger from electrical equipment. No materials on any of the site or work shall be so stacked or placed as to cause danger or inconvenience to any person or the public. The contractor shall provide all necessary fencing and lights to protect the public from accident and shall be bound to bear the expenses of defense of every suit, action or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions and to pay any damages and cost which may be awarded in any such suit, action or proceedings to any such person on which may, with the consent of the contractor, be paid to compensate any claim by any such person.
6. a. **Excavation and Trenching** – All trenches 1.2 m. (4ft.) or more in depth, shall at all times be supplied with at least one ladder for each 30m. (100ft.) in length or fraction thereof, Ladder shall extend from bottom of the Trench to at least 90cm (3fts) above the surface of the ground. The side of the trenches which are 1.5 m. (5 ft.) or more in depth shall be stepped back to give suitable slope or securely held by timber bracing, so as to avoid the danger of sides collapsing. The excavated material shall not be placed within 1.5 m. (5 ft.) of the edges of the trench or half of the depth of the trench whichever is more. Cutting shall be done from top to bottom. Under no circumstances, undermining or undercutting shall be done.

**b. Safety Measures for digging bore holes:-**

- i. If the bore well is successful, it should be safely capped to avoid caving and collapse of the bore well. The failed and the abandoned ones should be completely refilled to avoid caving and collapse;
  - ii. During drilling, Sign boards should be erected near the site with the address of the drilling contractor and the Engineer-in-charge of the work;
  - iii. Suitable fencing should be erected around the well during the drilling and after the installation of the rig on the point of drilling, flags shall be put 50 Mtr all around the point of drilling to avoid entry of people/animals;
  - iv. After drilling the bore well, a cement platform (0.50 Mtr x 0.50 Mtr x 1.20 Mtr) 0.60 Mtr above ground level and 0.60 Mtr below ground level should be constructed around the well casing;
  - v. After the completion of the bore well, the contractor should cap the bore well properly by welding steel plate, cover the bore well with the drilled wet soil and fix thorny shrubs over the soil. This should be done even while repairing the pump;
  - vi. After the bore well is drilled the entire site should be brought to the ground level;
7. Demolition – Before any demolition work is commenced and also during the progress of the work,
- i) All roads and open areas adjacent to the work site shall either be closed or suitably protected.
  - ii) No electric cable or apparatus which is liable to be a source of danger or a cable or apparatus used by the operator shall remain electrically charged.
  - iii) All practical steps shall be taken to prevent danger to persons employed from risk of fire or explosion or flooding. No floor, roof or other part of the building shall be so overloaded with debris or materials as to render it unsafe.
8. All necessary personal safety equipment as considered adequate by the Engineer-in-Charge should be kept available for the use of the person employed on the site and maintained in a condition suitable for immediate use, and the contractor should take adequate steps to ensure proper use of equipment by those concerned. The following safety equipment shall invariably be provided.
- i) Workers employed on mixing asphaltic materials, cement and lime mortars shall be provided with protective footwear and protective goggles.
  - ii) Those engaged in white washing and mixing or stacking of cement bags or any material which is injurious to the eyes shall be provided with protective goggles.
  - iii) Those engaged in welding works shall be provided with welder's protective eye-shields.
  - iv) Stone breaker shall be provided with protective goggles and protective clothing and seated at sufficiently safe intervals.
  - v) When workers are employed in sewers and manholes, which are in active use, the contractors shall ensure that the manhole covers are opened and ventilated at least for an hour before the workers are allowed to get into the manholes, and the manholes so opened shall be cordoned off with suitable railing and provided with warning signals or boards to prevent accident to the public. In addition, the contractor shall ensure that the following safety measures are adhered to:-
    - a) Entry for workers into the line shall not be allowed except under supervision of the Sr. Superintendent (Engg.) or any other higher officer.
    - b) At least 5 to 6 manholes upstream and downstream should be kept open for at least 2 to 3 hours before any man is allowed to enter into the manhole for working inside.
    - c) Before entry, presence of toxic gases should be tested by inserting wet lead acetate paper which changes colour in the presence of such gases and gives indication of their presence.

- d) Presence of Oxygen should be verified by lowering a detector lamp into the manhole. In case, no Oxygen is found inside the sewer line, workers should be sent only with oxygen kit.
  - e) Safety belt with rope should be provided to the workers. While working inside the manholes, such rope should be handled by two men standing outside to enable him to be pulled out during emergency.
  - f) The area should be barricaded or cordoned off by suitable means to avoid mishaps of any kind. Proper warning signs should be displayed for the safety of the public whenever cleaning works are undertaken during night or day.
  - g) No smoking or open flames shall be allowed near the blocked manhole being cleaned.
  - h) The malba obtained on account of cleaning of blocked manholes and sewer lines should be immediately removed to avoid accidents on account of slippery nature of the malba.
  - i) Workers should not be allowed to work inside the manhole continuously. He should be given rest intermittently. The Engineer-in-Charge may decide the time upto which a worker may be allowed to work continuously inside the manhole.
  - j) Gas masks with Oxygen Cylinder should be kept at site for use in emergency.
  - k) Air-blowers should be used for flow of fresh air through the manholes. Whenever called for, portable air blowers are recommended for ventilating the manholes. The Motors for these shall be vapour proof and of totally enclosed type. Non sparking gas engines also could be used but they should be placed at least 2 meters away from the opening and on the leeward side protected from wind so that they will not be a source of friction on any inflammable gas that might be present.
  - l) The workers engaged for cleaning the manholes / sewers should be properly trained before allowing to work in the manhole.
  - m) The workers shall be provided with Gumboots or non-sparking shoes bump helmets and gloves non sparking tools safety lights and gas masks and portable air blowers (when necessary). They must be supplied with barrier cream for anointing the limbs before working inside the sewer lines.
  - n) Workmen descending a manhole shall try each ladder stop or rung carefully before putting his full weight on it to guard against insecure fastening due to corrosion of the rung fixed to manhole well.
  - o) If a man has received a physical injury, he should be brought out of the sewer immediately and adequate medical aid should be provided to him.
  - p) The extent to which these precautions are to be taken depend on individual situation but the decision of the Engineer-in-Charge regarding the steps to be taken in this regard in an individual case will be final.
  - (vi) The Contractor shall not employ men and women below the age of 18 years on the work of painting with products containing lead in any form. Wherever men above the age of 18 are employed on the work of lead painting, the following precaution should be taken:-
    - a) No paint containing lead or lead products shall be used except in the form of paste or ready made paint.
    - b) Suitable face masks should be supplied for use by the workers when paint is applied in the form of spray or a surface having lead paint is dry rubbed and scrapped.
    - c) Overall shall be supplied by the contractors to the workmen and adequate facilities shall be provided to enable the working painters to wash during and on the cessation of work.
9. An additional clause (viii)(i) of AAI Safety Code (iv) the Contractor shall not employ women and men below the age of 18 on the work of painting with product containing lead in any form, wherever men above the age of 18 are employed on the work of lead painting, the following principles must be observed for such use:
- i) White lead, sulphate of lead or product containing these pigment, shall not be used in painting operation except in the form of pastes or paint ready for use.
  - ii) Measures shall be taken, wherever required in order to prevent danger arising from the application of a paint in the form of spray.

- iii) Measures shall be taken, wherever practicable, to prevent danger arising out of from dust caused by dry rubbing down and scraping.
  - iv) Adequate facilities shall be provided to enable working painters to wash during and on cessation of work.
  - v) Overall shall be worn by working painters during the whole of working period.
  - vi) Suitable arrangement shall be made to prevent clothing put off during working hours being spoiled by painting materials.
  - vii) Cases of lead poisoning and suspected lead poisoning shall be notified and shall be subsequently verified by medical man appointed by competent authority of AAI.
  - viii) AAI may require, when necessary medical examination of workers.
  - ix) Instructions with regard to special hygienic precautions to be taken in the painting trade shall be distributed to working painters.
10. When the work is done near any place where there is risk of drowning, all necessary equipments should be provided and kept ready for use and all necessary steps taken for prompt rescue of any person in danger and adequate provision, should be made for prompt first aid treatment of all injuries likely to be obtained during the course of the work.
11. Use of hoisting machines and tackle including their attachments, anchorage and supports shall conform to the following standards or conditions:
- i) (a) These shall be of good mechanical construction, sound materials and adequate strength and free from patent defects and shall be kept repaired and in good working order.  
(b) Every rope used in hoisting or lowering materials or as a means of suspension shall be of durable quality and adequate strength, and free from patent defects.
  - ii) Every crane driver or hoisting appliance operator shall be properly qualified and no person under the age of 21 years should be in charge of any hoisting machine including any scaffolding winch or give signals to operator.
  - iii) In case of every hoisting machine and of every chain ring hook, shackle swivel and pulley block used in hoisting or as means of suspension, the safe working load shall be ascertained by adequate means. Every hoisting machine and all gear referred to above shall be plainly marked with the safe working load. In case of a hoisting machine having a variable safe working load each safe working load and the condition under which it is applicable shall be clearly indicated. No part of any machine or any gear referred to above in this paragraph shall be loaded beyond the safe working load except for the purpose of testing.
  - iv) In case of departmental machines, the safe working load shall be notified by the Electrical Engineer-in-Charge. As regards contractor's machines the contractors shall notify the safe working load of the machine to the Engineer-in-Charge whenever he brings any machinery to site of work and get it verified by the electrical Engineer concerned.
12. Motors, gearing, transmission, electric wiring and other dangerous parts of hoisting appliances should be provided with efficient safeguards. Hoisting appliances should be provided with such means as will reduce to the minimum the risk of accidental descent of the load. Adequate precautions should be taken to reduce to the minimum the risk of any part of a suspended load becoming accidentally displaced. When workers are employed on electrical installations which are already energized, insulating mats, wearing apparel, such as gloves, sleeves and boots as may be necessary should be provided. The worker should not wear any rings, watches and carry keys or other materials which are good conductors of electricity.
13. All scaffolds, ladders and other safety devices mentioned or described herein shall be maintained in safe condition and no scaffold, ladder or equipment shall be altered or removed while it is in use. Adequate washing facilities should be provided at or near places of work.



14. These safety provisions should be brought to the notice of all concerned by display on a notice board at a prominent place at work spot. The person responsible for compliance of the safety code shall be named therein by the contractor.
15. To ensure effective enforcement of the rules and regulations relating to safety precautions the arrangements made by the contractor shall be open to inspection by the Labour Officer or Engineer-in- Charge of the department or their representatives.
16. Notwithstanding the above clauses from (1) to (15), there is nothing in these to exempt the contractor from the operations of any other Act or Rules in force in the Republic of India.

## MODEL RULES FOR THE PROTECTION OF HEALTH AND SANITARY ARRANGEMENTS FOR WORKERS EMPLOYED BY AAI OR ITS CONTRACTORS

### 1. APPLICATION

These rules shall apply to all buildings and construction works in charge of AAI in which twenty or more workers are ordinarily employed or are proposed to be employed in any day during the period during which the contract work is in progress.

### 2. DEFINITION

Work place means a place where twenty or more workers are ordinarily employed in connection with construction work on any day during the period during which the contract work is in progress.

### 3. FIRST-AID FACILITIES

- (i) At every work place, there shall be provided and maintained, so as to be easily accessible during working hours, first-aid boxes at the rate of not less than one box for 150 contract labour or part thereof ordinarily employed.
- (ii) The first-aid box shall be distinctly marked with a red cross on white background and shall contain the following equipment.
  - (a) For work places in which the number of contract labour employed does not exceed 50 Each first-aid box shall contain the following equipments:
    1. 6 small sterilized dressings
    2. 3 medium size sterilized dressings
    3. 3 large size sterilized dressings
    4. 3 large sterilized burn dressings
    5. 1 (30 ml) bottle containing a two per cent alcoholic solution of iodine.
    6. 1 (30 ml) bottle containing sal volatile having the dose and mode of administration indicated on the label.
    7. 1 snake bite lancet.
    8. 1 (30 gms) bottle of potassium permanganate crystals.
    9. 1 pair scissors.
    10. 1 copy of the first-aid leaflet issued by the Director General, Factory Advice Service and Labour Institute, Government of India.
    11. 1 bottle containing 100 tablets (each of 5 gms) of aspirin.
    12. Ointment for burns.
    13. A bottle of suitable surgical antiseptic solution.
  - (b) For work places in which the number of contract labour exceed 50. Each first-aid box shall contain the following equipments.
    1. 12 small sterilized dressings.
    2. 6 medium size sterilized dressings.
    3. 6 large size sterilized dressings
    4. 6 large size sterilized burn dressings.
    5. 6 (15 gms) packets sterilized cotton wool.
    6. 1 (60 ml). Bottle containing two per cent alcoholic solution iodine.
    7. 1 (60 ml) bottle containing sal volatile having the dose and mode of administration indicated on the label.
    8. 1 roll of adhesive plaster.
    9. 1 snake bite lancet.
    10. 1 (30 gms) bottle of potassium permanganate crystals.
    11. 1 pair scissors.
    12. 1 copy of the first-aid leaflet issued by the Director General Factory Advice Service and Labour Institute / Government of India.
    13. A bottle containing 100 tablets (each of 5 gms) of aspirin.

14. Ointment for burns.
15. A bottle of suitable surgical antiseptic solution.

- (iii) Adequate arrangements shall be made for immediate recoupment of the equipment when necessary.
- (iv) Nothing except the prescribed contents shall be kept in the First-aid box.
- (v) The first-aid box shall be kept in charge of a responsible person who shall always be readily available during the working hours of the workplace.
- (vi) a person in charge of the First-aid box shall be a person trained in First-aid treatment in the work places where the number of contract labour employed is 150 or more.
- (vii) In work places where the number of contract labour employed is 500 or more and hospital facilities are not available within easy distance from the works. First-aid posts shall be established and run by a trained compounder. The compounder shall be on duty and shall be available at all hours when the workers are at work.
- (viii) Where work places are situated in places which are not towns or cities, a suitable motor transport shall be kept readily available to carry injured person or person suddenly taken ill to the nearest hospital.

#### **4. DRINKING WATER**

- i) In every work place, there shall be provided and maintained at suitable places, easily accessible to labour, a sufficient supply of cold water fit for drinking.
- ii) Where drinking water is obtained from an intermittent public water supply, each work place shall be provided with storage where such drinking water shall be stored.
- iii) Every water supply or storage shall be at a distance of not less than 50 feet from any latrine drain or other source of pollution. Where water has to be drawn from an existing well which is within such proximity of latrine, drain or any other source of pollution, the well shall be properly chlorinated before water is drawn from it for drinking. All such wells shall be entirely closed in and be provided with a trap door which shall be dust and waterproof.
- iv) A reliable pump shall be fitted to each covered well, the trap door shall be kept locked and opened only for cleaning or inspection which shall be done at least once a month.

#### **5. WASHING FACILITIES**

- i) In every work place adequate and suitable facilities for washing shall be provided and maintained for the use of contract labour employed therein.
- ii) Separate and adequate cleaning facilities shall be provided for the use of male and female workers.
- iii) Such facilities shall be conveniently accessible and shall be kept in clean and hygienic condition.

#### **6. LATRINES AND URINALS**

- i) Latrines shall be provided in every work place on the following scale namely:
  - a) Where female are employed, there shall be at least one latrine for every 25 females.
  - b) Where males are employed, there shall be at least one latrine for every 25 males.
- ii) Provided that, where the number of males or females exceeds 100, it shall be sufficient if there is one latrine for 25 males or females as the case may be up to the first 100, and one for every 50 thereafter.
- iii) Every latrine shall be under cover and so partitioned off as to secure privacy, and shall have a proper door and fastenings.
- iv) Construction of latrines: The inside walls shall be constructed of masonry or some suitable heat-resisting nonabsorbent materials and shall be cement washed inside and outside at least once a year, Latrines shall not be of a standard lower than borehole system.

- v) (a) Where workers of both sexes are employed, there shall be displayed outside each block of latrine and urinal, a notice in the language understood by the majority of the workers "For Men only" or "For Women Only" as the case maybe.  
(b) The notice shall also bear the figure of a man or of a woman, as the case may be.
- vi) There shall be at least one urinal for male workers upto 50 and one for female workers upto fifty employed at a time, provided that where the number of male or female workmen, as the case may be exceeds 500, it shall be sufficient if there is one urinal for every 50 males or females upto the first 500 and one for every 100 or part hereafter.
- vii) (a) The latrines and urinals shall be adequately lighted and shall be maintained in a clean and sanitary condition at alltimes.  
(b) Latrines and urinals other than those connected with a flush sewage system shall comply with the requirements of the Public Health Authorities.
- viii) Water shall be provided by means of tap or otherwise so as to be conveniently accessible in or near the latrines andurinals.
- ix) Disposal of excreta: Unless otherwise arranged for by the local sanitary authority, arrangements for proper disposal of excreta by incineration at the work place shall be made by means of a suitable incinerator. Alternately excreta may be disposed of by putting a layer of night soil at the bottom of a pucca tank prepared for the purpose and covering it with a 15 cm. Layer of waste or refuse and then covering it with a layer of earth for a fortnight (when it will turn tomanure).
- x) The contractor shall at his own expense, carry out all instructions issued to him by the Engineer-in-Charge to effect proper disposal of night soil and other conservancy work in respect of the contractor's workmen or employees on the site. The contractor shall be responsible for payment of any charges which may be levied by Municipal or Cantonment Authority for execution of such on hisbehalf.

## 7. PROVISION OF SHELTER DURINGREST

At every place there shall be provided, free of cost, four suitable sheds, two for meals and the other two for rest separately for the use of men and women labour. The height of each shelter shall not be less than 3 meters (10 ft.) from the floor level to the lowest part of the roof. These shall be kept clean and the space provided shall be on the basis of 0.6 sq.m. (6 sft) per head. Provided that the Engineer-in-Charge may permit subject to his satisfaction, a portion of the building under construction or other alternative accommodation to be used for the purpose.

## 8. CRECHES

- i) At every work place, at which 20 or more women workers are ordinarily employed, there shall be provided two rooms of reasonable dimensions for the use of their children under the age of six years. One room shall be used as a play room for the children and the other as their bedroom. Theroomsshallbeconstructedwithspecificationsasperclause19H  
(ii) a,b& c.
- ii) The rooms shall be provided with suitable and sufficient openings for light and ventilation. There shall be adequate provision of sweepers to keep the placesclean.
- iii) The contractor shall supply adequate number of toys and games in the play room and sufficient number of cots and beddings in the bedroom.
- iv) The contractor shall provide one ayaa to look after the children in the crèche when the number of women workers does not exceed 50 and two when the number of women workers exceed50.
- v) The use of the rooms earmarked as crèches shall be restricted to children, their attendants and mothers of thechildren.

## 9. CANTEENS

- i) In every work place where the work regarding the employment of contractor labour is likely to continue for six months and where in contract labour numbering one hundred or more are ordinarily employed, an adequate canteen shall be provided by the contractor for the use of such contractlabour.
- ii) The canteen shall be maintained by the contractor in an efficientmanner.
- iii) The canteen shall consist of at least a dining hall, kitchen, storeroom, pantry and washing places separately for workers andutensils.
- iv) The canteen shall be sufficiently lighted at all times when any person has access toit.
- v) The floor shall be made of smooth and impervious materials and inside walls shall be limewashed or colour washed at least once in each year.Provided that the inside walls of the kitchen shall be lime washed every fourmonths.
- vi) The premises of the canteen shall be maintained in a clean and sanitarycondition.
- vii) Waste water shall be carried away in suitable covered drains and shall not be allowed to accumulate so as to cause anuisance.
- viii) Suitable arrangements shall be made for the collection and disposal ofgarbage.
- ix) The dining hall shall accommodate at a time 30 per cent of the contract labour working at a time.
- x) The floor area of the dining hall, excluding the area occupied by the service counter and any furniture except tables and chairs shall not be less than one square meter (10 sft) per diner to be accommodated as prescribed in sub-Rule(ix).
- xi) (a) A portion of the dining hall and service counter shall be partitioned off and reserved for women workers in proportion to their number. (b) Washing places for women shall be separate and screened to secureprivacy.
- xii) Sufficient tables stools, chairs or benches shall be available for the number of diners to be accommodated as prescribed in sub-Rule (ix).
- xiii) (a) 1. There shall be provided and maintained sufficient utensils crockery, furniture and any other equipment necessary for the efficient running of thecanteen.  
2.The furniture utensils and other equipment shall be maintained in a clean and hygienic condition.  
(b) 1. Suitable clean clothes for the employees serving in the canteen shall be provided andmaintained.  
2. A service counter, if provided, shall have top of smooth and imperviousmaterial.  
3. Suitable facilities including an adequate supply of hot water shall be provided for the cleaning of utensils andequipments.
- xiv) The food stuffs and other items to be served in the canteen shall be in conformity with the normal habits of the contractlabour.
- xv) The charges for food stuffs, beverages and any other items served in the canteen shall be based on 'No Profit, No loss' and shall be conspicuously displayed in thecanteen.
- xvi) In arriving at the price of foodstuffs, and other article served in the canteen, the following items shall not be taken into consideration as expenditure namely:-
  - a) The rent of land andbuilding.
  - b) The depreciation and maintenance charges for the building and equipments provided for thecanteen.
  - c) The cost of purchase, repairs and replacement of equipments including furniture, crockery, cutlery andutensils.
  - d) The water charges and other charges incurred for lighting andventilation.
  - e) The interest and amounts spent on the provision and maintenance of equipments provided for thecanteen.
- xvii) The accounts pertaining to the canteen shall be audited once every 12 months by registered accountants andauditors.

## **10. ANTI-MALARIAL PRECAUTIONS**

The contractor shall at his own expense, conform to all anti-malarial instructions given to him by the Engineer-in-Charge including the filling up of any borrow pits which may have been dug by him.

- 11.** The above rules shall be incorporated in the contracts and in notices inviting tenders and shall form an integral part of the contracts.

## **12. AMENDMENTS**

AAI may, from time to time, add to or amend these rules and issue directions - it may consider necessary for the purpose of removing any difficulty which may arise in the administration thereof.

## AIRPORTS AUTHORITY OF INDIA

### Contractor's Labour Regulations

#### 1. SHORTTITLE

These regulations may be called the AAI Contractors Labour Regulations.

#### 2. DEFINITIONS

(i) **Workman** means any person employed by AAI or its contractor directly or indirectly through a subcontractor with or without the knowledge of the AAI to do any skilled, semiskilled or unskilled manual, supervisory, technical or clerical work for hire or reward, whether the terms of employment are expressed or implied but does not include any person:-

- a) Who is employed mainly in a managerial or administrative capacity:or
- b) Who, being employed in a supervisory capacity draws wages exceeding five hundred rupees per mensem or exercises either by the nature of the duties attached to the office or by reason of powers vested in him, functions mainly of managerial nature :or
- c) Who is an out worker, that is to say, person to whom any article or materials are given out by or on behalf of the principal employers to be made up cleaned, washed, altered, ornamental finished, repaired adopted or otherwise processed for sale for the purpose of the trade or business of the principal employers and the process is to be carried out either in the home of the out worker or in some other premises, not being premises under the control and management of the principal employer. No person below the age of 14 years shall be employed to act as a workman.

(ii) **Fair Wages** means wages whether for time or piece work fixed and notified under the provisions of the Minimum Wages Act from time to time.

(iii) **Contractors** shall include every person who undertakes to produce a given result other than a mere supply of goods or articles of manufacture through contract labour or who supplies contract labour for any work and includes a subcontractor.

(iv) **Wages** shall have the same meaning as defined in the Payment of Wages Act.

3. i) Normally working hours of an adult employee should not exceed 9 hours a day. The working day shall be so arranged that inclusive of interval for rest, if any, it shall not spread over more than 12 hours on any day.
- ii) When an adult worker is made to work for more than 9 hours on any day or for more than 48 hours in any week, he shall be paid over time for the extra hours put in by him at double the ordinary rate of wages.
- iii) a) Every worker shall be given a weekly holiday normally on a Sunday, in accordance with the provisions of the Minimum Wages (Central) Rules 1960 as amended from time to time irrespective of whether such worker is governed by the Minimum Wages Act or not.
- b) Where the minimum wages prescribed by the Central/State Government under the Minimum Wages Act are not inclusive of the wages for the weekly day of rest, the worker shall be entitled to rest day wages at the rate applicable to the next preceding day, provided he has worked under the same contractor for a continuous period of not less than 6 days.
- c) Where a contractor is permitted by the Engineer-in-Charge to allow a worker to work on a normal weekly holiday, he shall grant a substituted holiday to him for the whole day on one of the five days immediately before or after the normal weekly holiday and pay wages to such worker for the work performed on the normal weekly holiday at overtime rate.

#### 4. DISPLAY OF NOTICE REGARDING WAGES ETC.

The contractor shall before he commences his work on contract, display and correctly maintain and continue to display and correctly maintain in a clear and legible condition in conspicuous places on the work, notices in English and in the local Indian languages spoken by the majority of the workers giving the minimum rates of wages fixed under Minimum Wages Act, the actual wages being paid, the hours of work for which such wages are earned, wages periods, dates of payments of wages and other relevant information as per Appendix 'VIII'.

## 5. PAYMENT OF WAGES

- (i) The contractor shall fix wage periods in respect of which wages shall be payable.
- (ii) No wage period shall exceed one month.
- (iii) The wages of every person employed as contract labour in an establishment or by a contractor where less than one thousand such persons are employed shall be paid before the expiry of seventh day and in other cases before the expiry of tenth day after the last day of the wage period in respect of which the wages are payable.
- (iv) Where the employment of any worker is terminated by or on behalf of the contractor the wages earned by him shall be paid before the expiry of the second working day from the date on which his employment is terminated.
- (v) All payment of wages shall be made on a working day at the work premises and during the working time and on a date notified in advance and in case the work is completed before the expiry of the wage period, final payment shall be made within 48 hours of the last working day.
- (vi) Wages due to every worker shall be paid to him direct or to other person authorized by him in his behalf.
- (vii) All wages shall be paid in current coin or currency or in both.
- (viii) Wages shall be paid without any deductions of any kind except those specified by the Central Government by general or special order in this behalf or permissible under the Payment of Wages Act 1956.
- (ix) A notice showing the wages period and the place and time of disbursement of wages shall be displayed at the place of work and a copy sent by the contractor to the Engineer-in-Charge under acknowledgement.
- (x) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the Senior Superintendent Engg or authorized representative of the Engineer-in-Charge who will be required to be present at the place and time of disbursement of wages by the contractor to workmen.
- (xi) The contractor shall obtain from Engineer in charge or the authorized representative of the Engineer-in-Charge a certificate under his signature at the end of the entries in the "Register of Wages" or the "Wage-cum-Muster Roll" as the case may be in the following form:  
 "Certified that the amount shown in column No. .... has been paid to the workman concerned in my presence on ..... at ....."

Note: In case of payment of wages paid through bank, the contractor shall submit a copy of bank statement for relevant period duly signed by him.

## 6. FINES AND DEDUCTIONS WHICH MAY BE MADE FROM WAGES

- (i) The wages of a worker shall be paid to him without any deduction of any kind except the following:
  - a) Fines
  - b) Deductions for absence from duty i.e. from the place or the places where by the terms of his employment he is required to work. The amount of deduction shall be in proportion to the period for which he was absent.
  - c) Deduction for damage to or loss of goods expressly entrusted to the employed person for custody, or for loss of money or any other deduction which he is required to account, where such damage or loss is directly attributable to his neglect or default.
  - d) Deduction for recovery of advances or for adjustment of overpayment of wages, advances granted shall be entered in a register.
  - e) Any other deduction which the Central Government may from time to time allow.
- (ii) No fines should be imposed on any worker save in respect of such acts and omissions on his part as have been approved of by the Chief Labour Commissioner.  
**Note:** An approved list of Acts and Omissions for which fines can be imposed is enclosed at Appendix-XII.

- (iii) No fine shall be imposed on a worker and no deduction for damage or loss shall be made from his wages until the worker has been given an opportunity of showing cause against such fines or deductions.
- (iv) The total amount of fine which may be imposed in any one wage period on a worker shall not exceed an amount equal to three paise in a rupee of the total wages, payable to him in respect of that wage period.
- (v) No fine imposed on any worker shall be recovered from him by installment, or after the expiry of sixty days from the date on which it was imposed.
- (vi) Every fine shall be deemed to have been imposed on the day of the act or omission in respect of which it was imposed.

## 7. LABOUR RECORDS

- (i) The contractor shall maintain a Register of persons employed on work on contract in Form XIII of the CL(R&A) Central Rules 1971 (Appendix VI)
- (ii) The contractor shall maintain a Muster Roll register in respect of all workmen employed by him on the work under Contract in Form XVI of the CL (R&A) Rules 1971 (Appendix VII).
- (iii) The contractor shall maintain a Wage Register in respect of all workmen employed by him on the work under contract in Form XVII of the CL (R&A) Rules 1971 (Appendix VIII)
- (iv) **Register of accident** - The contractor shall maintain a register of accidents in such form as may be convenient at the work place but the same shall include the following particulars:
  - (a) Full particulars of the labourers who met with accident.
  - (b) Rate of Wages
  - (c) Sex
  - (d) Age
  - (e) Nature of accident and cause of accident
  - (f) Time and date of accident
  - (g) Date and time when admitted in Hospital
  - (h) Date of discharge from the Hospital
  - (i) Period of treatment and result of treatment
  - (j) Percentage of loss of earning capacity and disability as assessed by Medical officer
  - (k) Claim required to be paid under Workmen's Compensation Act.
  - (l) Date of payment of compensation
  - (m) Amount paid with details of the person to whom the same was paid
  - (n) Authority by whom the compensation was assessed.
  - (o) Remarks
- (v) The contractor shall maintain a **Register of Fines** in the Form XII of the CL(R&A) Rules 1971 (Appendix-XIII).  
The contractor shall display in a good condition and in a conspicuous place of work the approved list of acts and omissions for which fines can be imposed (Appendix-XII)
- (vi) The contractor shall maintain a **Register of deductions for damage or loss** in Form XX of the CL (R&A) Rules 1971 (Appendix-XIV)
- (vii) The contractor shall maintain a **Register of Advances** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XV)
- (viii) The contractor shall maintain a **Register of Overtime** in Form XXIII of the CL (R&A) Rules 1971 (Appendix-XVI).

## 8. ATTENDANCE CARD-CUM-WAGESLIP

- (i) The contractor shall issue an **Attendance card-cum-wage** slip to each workman employed by him in the specimen form at (Appendix-IX)
- (ii) The card shall be valid for each wage period.
- (iii) The contractor shall mark the attendance of each workman on the card twice each day, once at the commencement of the day and again after the rest interval, before he actually starts work.
- (iv) The card shall remain in possession of the worker during the wage period under reference.



- (v) The contractor shall complete the wage slip portion on the reverse of the card at least a day prior to the disbursement of wages in respect of the wage period underreference.
- (vi) The contractor shall obtain the signature or thumb impression of the worker on the wage slip at the time of disbursement of wages and retain the card withhimself.

## 9. EMPLOYMENTCARD

The contractor shall issue an **Employment Card** in Form XIV of the CL (R&A) Central Rules 1971 to each worker within three days of the employment of the worker(Appendix-X).

## 10. SERVICECERTIFICATE

On termination of employment for any reason whatsoever the contractor shall issue to the workman whose services have been terminated, a **Service certificate** in Form XV of the CL(R&A) Central Rules 1971.

## 11. PRESERVATION OF LABOURRECORDS

All records required to be maintained under Regulations Nos. 6 & 7 shall be preserved in original for a period of three years from the date of last entries made in them and shall be made available for inspection by the Engineer-in-Charge or Labour Officer or any other officers authorized by the Ministry of Urban Development in this behalf.

## 12. POWER OF LABOUR OFFICER TO MAKE INVESTIGATIONS ORENQUIRY

The Labour Officer or any person authorized by Central Government on their behalf shall have power to make enquiries with a view to ascertaining and enforcing due and proper observance of Fair Wage Clauses and the Provisions of these Regulations. He shall investigate into any complaint regarding the default made by the contractor or subcontractor in regard to suchprovision.

## 13. REPORT OF LABOUROFFICER

The Labour Officer or other persons authorized as aforesaid shall submit a report of result of his investigation or enquiry to the Engineer-in-Charge concerned indicating the extent, if any, to which the default has been committed with a note that necessary deductions from the contractor's bill be made and the wages and other dues be paid to the labourers concerned. In case an appeal is made by the contractor under Clause 13 of these regulations, actual payment to labourers will be made by the Engineer-in-Charge after G.M. Engg. has given his decision on such appeal.

(i) Engineer-in-Charge shall arrange payments to the labour concerned within 45 days from the receipt of the report from the Labour Officer or the G.M. Engineer as the case maybe.

## 14. APPEAL AGAINST THE DECISION OF LABOUROFFICER

Any person aggrieved by the decision and recommendations of the Labour Officer or other person so authorized may appeal against such decision to the Engineer-in-Charge concerned within 30 days from the date of decision, but subject to such appeal, the decision of the officer shall be final and binding upon the contractor.

## 15. PROHIBITION REGARDING REPRESENTATION THROUGHAWYER

- (i) A workman shall be entitled to be represented in any investigation or enquiry under these regulations by:
  - a) An officer of a registered trade union of which he is amember.
  - b) An officer of a federation of trade unions to which the trade union referred to in Clause (a) is affiliated.

- c) Where the employer is not a member of any registered trade union, by an officer of a registered trade union, connected with the industry in which the worker is employed or by any other workman employed in the industry in which the worker is employed.
- (ii) An employer shall be entitled to be represented in any investigation or enquiry under these regulations by:
  - a) An officer of an association of employers of which he is a member.
  - b) An officer of a federation of associations of employers to which association referred to in Clause(a) is affiliated.
  - c) Where the employer is not a member of any association of employers, by an officer of association of employer connected with the industry in which the employer is engaged or by any other employer, engaged in the industry in which the employer is engaged.
- (iii) No party shall be entitled to be represented by a legal practitioner in any investigation or enquiry under these regulations.

**16. INSPECTION OF BOOKS AND SLIPS**

The contractor shall allow inspection of all the prescribed labour records to any of his workers or to his agent at a convenient time and place after due notice is received or to the Labour Officer or any other person, authorized by the Central Government on his behalf .

**17. SUBMISSION OF RETURNS**

The contractor shall submit periodical returns as may be specified from time to time.

**18. AMENDMENTS**

The Central Government/AAI may from time to time add to or amend the regulations and on any question as to the application/interpretation or effect of those regulations the decision of the General Manager (Engg.) concerned shall be final.

We, the said Bank, further agree that the Guarantee herein contained shall remain in full force and effect during the period that would be taken for the performance of the said contracts and till all the dues of AAI under the said contract or by virtue of any of the terms and conditions governing the said contract including compensation for delay if any as decided by AAI, have been fully paid and its claims satisfied or discharged and till the Accepting Authority of the contract certifies that the terms and condition and accordingly Contract have been fully and properly carried out by the said contractor and accordingly discharges this guarantee subject, however that AAI shall have no claim under this Guarantee after 90(Ninety) days from the date of expiry of the defects Liabilities periods or Final /Extension of Time grated by AAI as provided available in agreements clause no.....as provided in the said Contract, i.e.....(date) or from the date of cancellation of the said contract, as the case may be, unless a notice of the claim under this Guarantee has been served on the Bank before the expiry of the period in which case the same shall be enforceable against the Bank notwithstanding the fact, that the same is enforced after the expiry of the saidperiod.

AND

.....represented by ..... of the other part, hereinafter called the “Bidder/Contractor “(which term shall unless excluded by or is repugnant to the context be deemed to include its heirs, representatives, successors and assigns of the Bidder/Contractor)

WHEREAS the Authority intends to award, under laid down organizational procedures, tender/ contractfor..... the Authority while discharging its functions on business principles values proper compliance with all relevant laws and regulations, and the principles of natural justice, equity, fairness and transparency in its relations with the Bidder/Contractors.

WHEREAS the Authority is desirous to make its business mechanism more transparent, and to ensure strict adherence of the aforesaid objectives/goals, the Authority hereby adopts an instrument developed by the renowned international non governmental organization “Transparency International” (T I ) headquartered in Berlin ( Germany ) and the Authority will appoint an Independent External Monitor (IEM) who will monitor the tender process and the execution of the contract for compliance with the principles mentioned above.

AND WHEREAS the Bidder is submitting a tender to the Authority for .....In pursuance to the NIT(Notice Inviting Tender) dated..... Contractor is signing the contract for execution of .....NOW, therefore, To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/patronized dealings prior to, during and subsequent to the currency of the contract entered into with a view to Enabling the Authority to obtain the desired said work/equipment/execution of works at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and Enabling Authority to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the Authority will commit to prevent corruption, in any form, by its officials by following transparent procedures. The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

**1. Commitments of the Authority;**

- 1.1 The Authority undertakes that no official of the Authority, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.
- 1.2 The Authority will, during the pre-contact stage, treat all BIDDERS alike, and will provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.
- 1.3 All the officials of the Authority will report to the appropriate authority office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such breach.
- 1.4 In case any such preceding misconduct on the part of such officer(s) is reported by the BIDDER to the Authority with full and veridical facts and the same is prima facie found to be correct, the Authority may initiate necessary disciplinary proceedings, or any other action as deemed fit including criminal proceedings may be initiated by the Authority and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the Authority the proceedings under the contract would not be stalled.

**1. Commitments of Bidders/Contractor.**

- The Bidder/Contractor commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following.
- 2.1 The Bidder/Contractor will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 2.2 The Bidder/Contractor further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the Authority or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Authority for showing or

Forbearing to show favour or disfavour to any person in relation to the contract or any other contract with the Authority.

- 23 The Bidder / Contactor has not entered and will not enter with other bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specification, certifications, subsidiary contracts, submission or non-submission of bids or any actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 24 The Bidder/Contractor shall, when presenting his bid, disclose the name and address of agents and representatives and Indian BIDDERS shall disclose their foreign principals or associates.
- 25 The Bidder/Contractor shall when presenting his bid disclose any and all the payments he has made or, is committed to or intends to make to agents, brokers or any other intermediary, in connection with this bid/contract.
- 26 The Bidder/Contractor further confirms and declares to the Authority that the BIDDER is the original manufacturer/integrator/ authorized government sponsored export entity of the stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate in any way to recommend to the Authority or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER. No amount has been paid, promised or intended to be paid to such individual, firm or company in respect of any such intercession/facilitation or recommendation.
- 27 The Bidder/Contractor, either while presenting the bid or during pre-contract negotiations or before signing the contract shall disclose all payments he has made or is committed to or intends to make to officials of the Authority or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 28 The Bidder/Contractor will not collude with other parties interested in the contract to impact the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 29 The Bidder/Contractor will not accept any advantage in exchange for any corrupt practices, unfair means and illegal activities.
- 2.10 The Bidder / Contactor will not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the Authority as part of the business relationship, regarding plans, technical proposals and business deals, including information contained in any electronic data carrier. The Bidder/Contractor also undertakes to exercise due and adequate care lest any such information is divulged.
- 2.11 The Bidder/Contractor will inform to the Independent External Monitor.
- i) If he receives demand for an illegal/undue payment/benefit.

- ii) If he comes to know of any unethical or illegal payment/benefit.
  - iii) If he makes any payment to any Authority's associate(s)
- 2.12 The Bidder/Contractor commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 2.13 The Bidder/Contractor shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 2.14 If the Bidder/Contractor or any employee of the Bidder/Contractor or any person acting on behalf of the Bidder/ Contractor, either directly or indirectly is a relative of any of the officers of the Authority, or alternatively, if any relative of an officer of the Authority has financial interest/stake in the Bidder's/Contractor's firm, the same shall be disclosed by the Bidder/Contractor at the time of tender. The term 'relative' for this purpose would be as defined in Section 2 of the Companies Act 1956.
- 2.15 The Bidder/Contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly with an employee of the Authority.
- 2.16 That if the Bidder/ Contractor, during tender process or before award of the contract or during execution of the contract work has committed a transgression in violation of section 2 or in any other manner such as to put his reliability or credibility as Bidder/Contractor into question, the Authority is entitled to disqualify him from the tender process or to terminate the contract for such reason and to debar the BIDDER from participating in future bidding processes.

- 3.1 The Bidder/Contractor declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify bidders exclusion from the tender process.
- 3.2 The Bidder/Contractor agrees that if he makes incorrect statement on this subject, he can be disqualified from the tender process or the contract, if already awarded, can be terminated for suspension and he may be considered for debarment for future tender/contract processes.
- 3.3 That the Bidder/Contractor undertakes to get this Pact signed by the subcontractor (s) and associate(s) whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees Zero point five Cr.) and to submit the same to the Authority along-with the tender document/ contract before contract signing.
- 3.4. That sub-contractor(s)/ associate(s) engaged by the Contractor, with the approval of the Authority after signing of the contract, and whose value of the work contribution exceeds Rs 0.5 Cr. (Rupees Zero point five Cr.) will be required to

sign this Pact by the Contractor, and the same will be submitted to the Authority before doing/ performing any act/ function by such subcontractor(s) / associate(s) in relation to the contract/ work.

3.5 That the Authority will disqualify from the tender process all Bidder(s) who don't sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority

3.6 That if the Contractor(s) does/ do not sign this Pact or violate its provisions or fails to get this Pact signed in terms of policy of authority. Authority will terminate the contract and initiate appropriate action against such Contractor(s)

**4. Earnest Money, Security Deposit, Bank Guarantee, Draft, Pay order or any other mode and its validity i/c Warranty Period, Performance Guarantee/Bond.**

While submitting bid, the BIDDER shall deposit an EMD/SD/BG/DRAFT/PAY ORDER ETC I/C WARRANTY PERIOD, PG/BOND, VALIDITY etc., which as per terms and conditions and details given in NIT/ tender document sold to the Bidders.

**5. Sanctions for Violations/Disqualification from tender process and exclusion from future Contacts.**

5.1 Any breach of the aforesaid provisions by the BIDDER or anyone employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the Authority to take all or any one of the following actions, wherever required:

- i) To immediately call off the present contract in situations with or without assigning any reason, giving adequate compensation to the BIDDER. However, the proceedings with the other BIDDERs would continue.
- ii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- iii) If the Authority has disqualified/ debarred the Bidder from the tender process prior to the award under section 2 or 3 or 4, the Authority is entitled to forfeit the earnest money deposited/bid security.
- iv) To recover all sums already paid by the Authority, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to the BIDDER from the Authority in connection with any other contract or any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.

- v) To en-cash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- vi) To cancel all or any other Contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the Authority resulting from such cancellation/rescission and the Authority shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- vii) To debar the BIDDER from participating in future bidding processes for a minimum period of three years, which may be further extended at the discretion of the Authority.
- viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- ix) In case where irrevocable Letters of Credit have been received in respect of any contract signed by the Authority with the BIDDER, the same shall not be opened.
- x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- xi) That if the Authority have terminated the contract under section 2 or 4 or if the Authority is entitled to terminate the contract under section 2 or 4, the Authority shall be entitled to demand and recover from contractor damages equivalent to 5% of the contract value or the amount equivalent to security deposit or performance bank guarantee, whichever is higher.
- xii) That the Bidder/Contractor shall undertake to pay the said amount without protest or demur subject only to condition that if the Bidder/Contractor can prove and establish to the satisfaction of the Authority that the disqualification / debarment of the bidder from the tender process or the termination of the contract after award of the contract has caused no damage to the Authority.

5.2 The Authority will be entitled to recall any of the actions mentioned at para 5.1 Above.

5.3 (i) to (xii) of this Pact also on the Commission by the BIDDER or any one employed by or acting on its behalf (whether with or without the knowledge of the BIDDER) of offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.

5.4 That if the Bidder/Contractor applies to the Authority for premature revocation of the debarment and proves to the satisfaction of the Authority that he has installed a suitable and effective corruption prevention system and also restored/recouped the damage, if any, caused by him, the Authority may, if thinks fit, revoke the debarment prematurely considering the facts and circumstances of the case, and the documents/evidence adduced by the Bidder/Contractor for first time default.

5.5 That a transgression is considered to have occurred if the Authority is fully satisfied with the available documents and evidence submitted along with Independent External Monitor's recommendations/suggestions that no reasonable doubt is possible in the matter.

5.6 The decision of the Authority to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent External Monitor(s) appointed for the purpose of this Pact.

**6. Allegations against Bidders/Contractors/ Sub-Contractors/Associates:**

That if the Authority receives any information of conduct of a Bidder, Contractor or Sub- Contractor or of an employee or a representative or an associate of the Bidder, Contractor or Sub- Contractor which constitutes corruption, and if the Authority has substantive suspicion in this regard, the Authority will inform the Vigilance Department for appropriate action.

**7. Independent External Monitor(s),**

7.1. That the Authority has appointed competent and credible Independent External Monitor(s) for this Pact.

7.2 The task of the Monitor(s) is to review independently and objectively whether and to what extent the parties comply with the obligations under this Pact. He will also enquire into any complaint alleging transgression of any provision of this Pact made by the Bidder, Contractor or Authority.

7.3. That the Monitor(s) is not subject to any instructions from the representatives of the parties and would perform his functions neutrally and independently. He will report to the Chairperson of the Board of the Authority.

7.4 That the Bidder / Contractor accepts that the Monitor(s) has the right to access without restriction to all project documentation of the Authority including that provided by the Bidder/Contractor. The Bidder/Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation including minutes of meeting. The same is applicable to Sub - Contractors and Associates. The Monitor is under obligation to treat the information and documents of the Authority and Bidder/ Contractor / Sub-Contractors/ Associates with confidentiality.

7.5. That as soon as the Monitor notices, or believes to notice, a violation of this Pact, he will so inform the management of the Authority and request the management

to discontinue or heal the violation, or to take other relevant action. The Monitor(s) can in this regard submit his recommendations/ suggestions. Beyond this, the Monitor(s) has no right to demand from the parties that they act in a specific manner, refrain from action or tolerate action.

7.6 That the Authority will provide to the Monitor(s) sufficient information about all meetings among the parties related to the project provided such meetings could have an impact on the contractual relations between the Authority and the Contractor / Bidder. The parties offer to the Monitor(s) the option to participate in such meetings.

7.7 That the Monitor(s) will submit a written report to the Chairperson of the Board of the Authority within 2 weeks from the date of reference or intimation to him by the Authority and, should the occasion arise, submit proposals for correcting problematic situations.

7.8 That if the Monitor(s) has reported to the Chairperson of the Board a substantiated suspicion of an offence under relevant Anti- Corruption Laws of India and the Chairperson has not, within reasonable time, taken visible action to proceed against such offence or reported to the Vigilance Department, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.

7.9 The word ‘Monitor’ would include similar and plus

**8. Facilitation of Investigation**

In case of any allegation of violation of any provision of this Pact or payment of commission, the Authority or its agencies shall be required to examine all the documents including Bank accounts of the BIDDER and the BIDDER and shall provide necessary information and documents in English and shall extend all possible help for the purpose of such Examination.

**9. Law and Place of Jurisdiction**

That this Pact is subject to provisions under Indian Law. The place of performance and jurisdiction is the Corporate Headquarter /the Regional Headquarter office of the Authority, as applicable.

**10. Other Legal Action**

10.1 That the changes and supplements as well as termination notice need to be made in writing.

10.2 That if the Bidder / Contractor are a partnership or a consortium, this Pact must be signed by all the partners and consortium members or their authorized representatives.



**11. Pact duration(Validity)**

- 11.1 That this Pact comes into force when both the parties have signed it. It expires for the Contractor 12 months after the final payment under the respective contract, and for all other Bidders 3 months after the contract is awarded.
- 11.2. That if any claim is made / lodged during this period, the same shall be binding and continue to be valid despite the lapse of this Pact as specified herein before, unless it is discharged/determined by Chairman of the Authority.
- 11.3 That should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact shall remain valid. In this case, the parties shall strive to come to an agreement to their original intentions.

**12. Company Code of Conduct**

Bidders are also advised to have a company code of conduct clearly reflecting the use of bribes and other unethical behavior and a compliance program for the implementation of the code of conduct throughout the company.

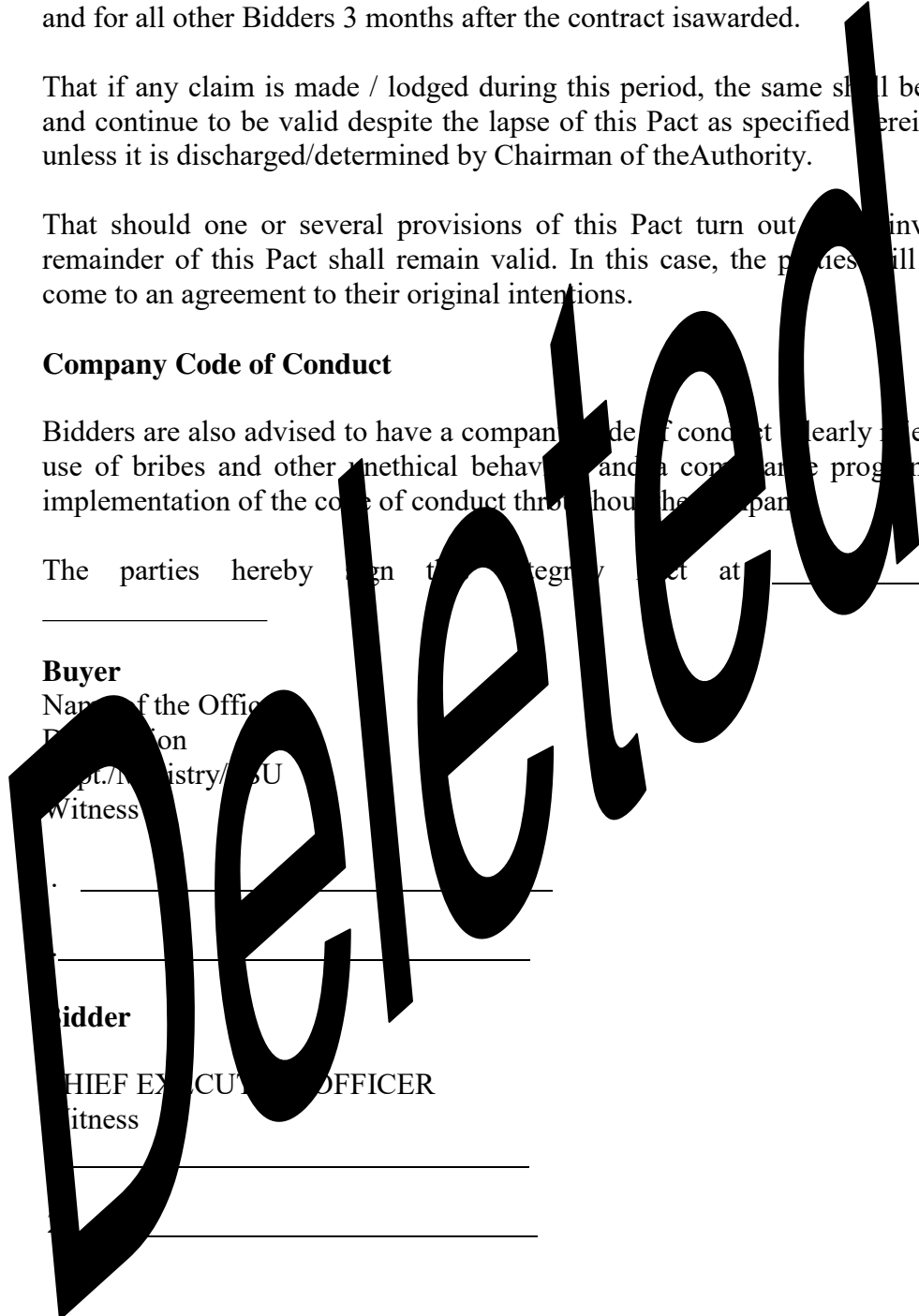

WHEREAS by an agreement dated ..... (hereinafter called the said agreement) the Contractor has agreed AND WHEREAS the Contractor has applied to the AAI that he may be allowed advances on the security of materials absolutely belonging to him and brought by him to the site of the works the subject of the said agreement for use in the construction of such of the works as he has undertaken to execute at rates fixed for the finished work (inclusive of the cost of materials and labour and other charges) AND WHEREAS the AAI has agreed to advance to the Contractor the sum of Rupees .... on the security of materials the quantities and other particulars of which are detailed in Accounts of Secured Advances attached to the Running Account Bill for the said works signed by the Contractor on ..... and the AAI has reserved to himself the option of making any further advance or advances on the security of other materials brought by the Contractor to the site of the said works. Now THIS INDENTURE WITNESSETH that in pursuance of the said agreement and in consideration of the sum of Rupees ..... on or before the execution of these presents paid to the Contractor by the AAI (the receipt whereof the Contractor doth hereby acknowledge) and of such further advances (if any) as may be made to him as aforesaid the Contractor doth hereby covenant and agree with the AAI and declare as follows: -

- (1) That the said sum of Rupees .. .. so advanced by the AAI to the Contractor as aforesaid and all or any further sum or sums advanced as aforesaid shall be employed by the Contractor in or towards expediting the execution of the said works and for no other purpose whatsoever.
- (2) That the materials detailed in the said Account of Secured Advances which have been offered to and accepted by the AAI as security are absolutely the Contractor's own property and free from encumbrances of any kind and the contractor will not make any application for or receive a further advance on the security of materials which are not absolutely his own property and free from encumbrances of any kind and the Contractor indemnifies the AAI against all claims to any materials in respect of which an advance has been made to him as aforesaid.
- (3) That the materials detailed in the said Account of Secured Advances and all other materials on the security of which any further advance or advances may hereafter be made as aforesaid (hereinafter called the said materials) shall be used by the Contractor solely in the execution of the said works in accordance with the directions of the Engineer-in-Charge of the project (hereinafter called the Engineer-in-Charge) and in the term of the said agreement.

- (4) That the Contractor shall make at his own cost all necessary and adequate arrangements for the proper watch, safe custody and protection against all risks of the said materials and that until used in construction as aforesaid the said materials shall remain at the site of the said works in the Contractor's custody and on his own responsibility and shall at all times be open to inspection by the Engineer-in-Charge or any officer authorised by him. In the event of the said materials or any part thereof being stolen, destroyed or damaged or becoming deteriorated in a greater degree than is due to reasonable use and wear thereof the Contractor will forthwith replace the same with other materials of like quality or repair and make good the same as required by the Engineer-in-Charge.
- (5) That the said materials shall not on any account be removed from the site of the said works except with the written permission of the Engineer-in-Charge or an officer authorised by him on that behalf.
- (6) That the advances shall be repayable in full when or before the Contractor receives payment from the AAI of the price payable to him for the said works under the terms and provisions of the said agreement. 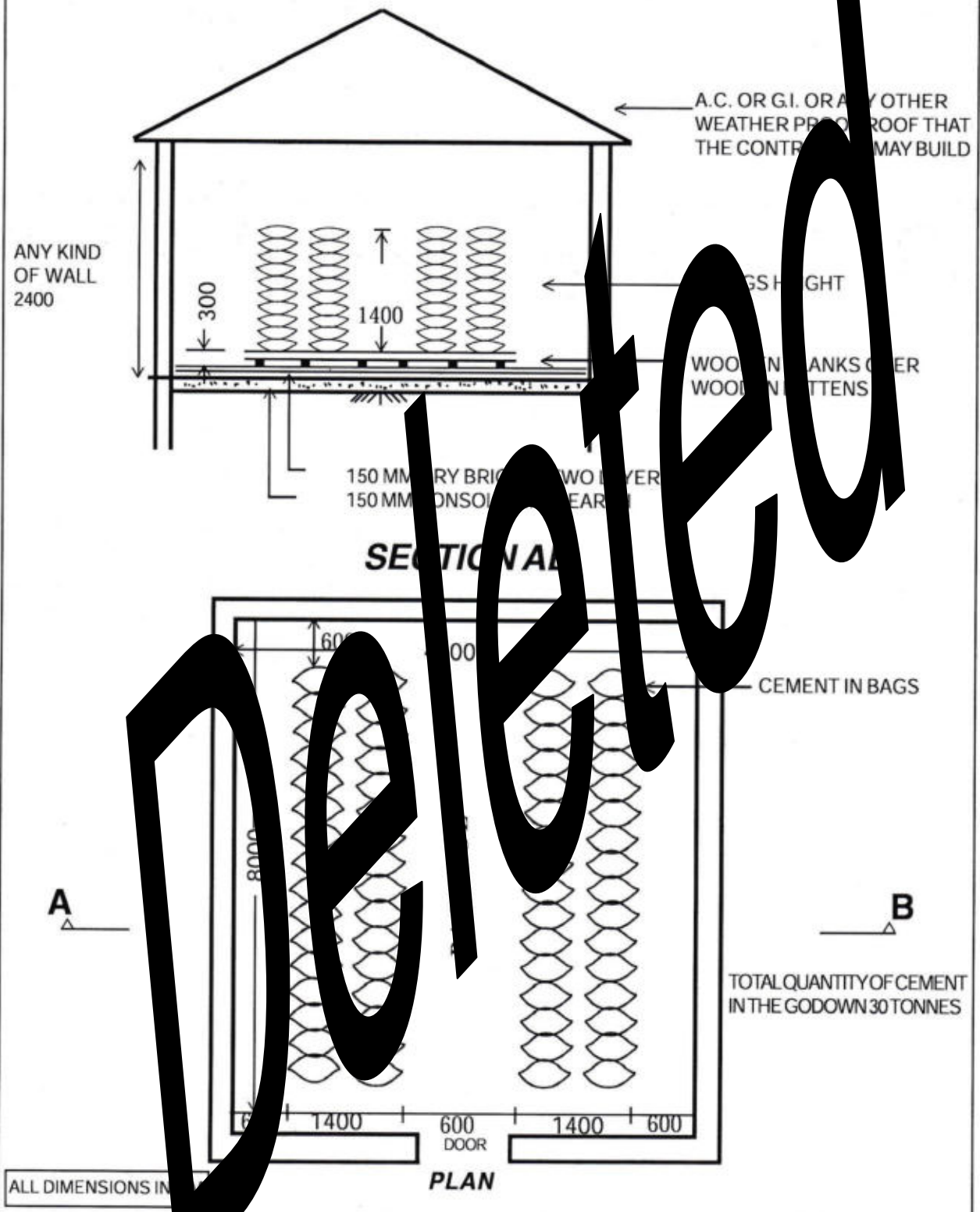

## **SPECIAL CONDITIONS**

### **1. GENERAL**

- 1.1 Special conditions of Contract shall be read in conjunction with General Conditions of Contract, Technical Specifications, Drawings and any other documents forming part of this contract wherever the context so requires.
- 1.2 Notwithstanding the sub-division of the documents into these separate sections and volume every part of each shall be deemed to be supplementary to and complementary of every other part and shall be read with and into the CONTRACT so far as it may be practicable to do so.
- 1.3 Where any portion of the General Condition of Contract is repugnant to or at variance with any provisions of the Special Conditions of Contract, unless a different intention appears, the provisions of the Special Conditions of Contract shall be deemed to over-ride the provisions of the General Conditions of Contract and shall to the extent of such repugnancy, or variations, prevail.

### **2. COMPLETION SCHEDULE**

- 2.1 The works shall be executed strictly as per time schedule mentioned in NIT. Contractor shall have to plan his construction program and activities so as to complete the work in the stipulated period. The period of completion given includes the time required for mobilization as well as testing, rectifications, if any, re-testing and completion in all respects to the entire satisfaction of Engineer-in-Charge.
- 2.2 Contractor is expected to mobilize and employ sufficient resources as indicated in the agreed Programme to achieve the progress within the broad frame work of accepted methods of working and safety. In time and progress chart, deployment of machineries, equipment's, apparatus and instruments are to be treated as one of the sections of the work.
- 2.3 No additional payment shall be made to the contractor for any multiple shift work or other incentive methods contemplated by him in his work schedule even though the time schedule is approved by the Engineer-in-Charge.
- 2.4 During the currency of the work the contractor is expected to adhere to the time schedule on mile stone and total completion and this adherence will be a part of Contractor's performance under the contract.
- 2.5 The Engineers-in-Charge can hold the payment till such time; the contractor does not submit CPM/Milestone Chart/Construction Equipment Program etc. The Contractor will be fully responsible to submit Milestone Chart in consultation with Engineer-in-Charge to complete the work within stipulated time.



### **3. DRAWINGS AND DOCUMENTS**

- 3.1 The drawings accompanying the tender document are of indicative nature and issued for tendering purpose with the purpose to enable the tenderer to make an offer in line with the requirements of the AAI.
- 3.2 However, no extra claim whatsoever, shall be entertained for variation in the "approved for construction" and "tender drawings" regarding any changes. The execution of work shall be as per approved drawings and detailed specifications.

### **4. BILL OF QUANTITIES**

- 4.1 The bill of quantities shall be read in conjunction with general conditions of contract 2010, special conditions of contract, technical specifications, drawings and any other document forming a part of this tender.

### **5. ROYALTY ON MATERIALS**

- 5.1 Royalty at the prevalent rates wherever payable, shall have to be paid by the contractor on the boulders, metal, shingle, sand, good earth, bajri etc. or any other materials collected by him for the work, direct to the revenue authority of the District / States Government concerned.

### **6. TEMPORARY WORKS**

- 6.1 The tendered should see the approaches and conditions of the same. If any approach from main road is required at site or existing approach is to be made and maintained for cartage of materials etc. by the contractor, the same shall be provided, improved and maintained by the contractor at his own cost.
- 6.2 All temporary and ancillary works including enabling works connected with the work shall be responsibility of the contractor and the price quoted by them shall be deemed to have included the cost of such works which shall be removed by the contractor at his cost, immediately after completion of the work.

### **7. PAYMENTS**

- 7.1 The bill shall be submitted at intervals as provided at clause no. 7 on page no.13 in schedule-F on or before the date fixed by the engineer-in-charge for all the works executed since previous bill in accordance with provision of clause 7 of GCC of the contract agreement.
- 7.2 The payment due to the contractor shall be made within 15 days of the submission of the bill by the contractor and the measurements shall be verified by the Engineer-in-Charge or his representative within 10 days of submission of the bill.
- 7.3 The bill shall not be entertained if the gross amount of the work done including secured advance payable is less than **Rs. 2,50,000/-** except Final Bill.



## **8. INCOME TAX AND LABOUR CESS**

- 8.1 Income tax deductions shall be made from all payments made to the contractor as per the rules and regulations in force in accordance with the income tax act prevailing from time to time.
- 8.2 Labour cess as per rules and regulations in force shall be deducted from the bills of the contractors and deposited with designated authorities.

## **9. WATER**

- 9.1 Contractor shall make his own arrangements for water supply for the work and his staff and workmen. AAI may provide water for the work depending upon the availability of water for which the water charges @ 1 % of the value of work done shall be deducted from the bill.

## **10. POWER SUPPLY**

- 10.1 Contractor shall make his own arrangements for power supply for the execution of the work, If available power may be supplied by AAI to contractor on chargeable basis.

## **11. CONTRACT AGREEMENT**

- 11.1 The contract agreement shall be executed on a non-judicial stamp paper of value Rs.100/- and cost of the stamp paper shall be borne by the contractor.
- 11.2 Contractor's tender including the letters of clarifications between the contractor and the AAI prior to the award of contract shall form a part of the contract agreement to the extent they have been accepted by AAI.

## **12. CONSTRUCTION EQUIPMENT**

- 12.1 The contractor shall without prejudice to his overall responsibility to execute and complete the work as per specifications and time schedule deploy adequate equipment's and tools and tackles and augment the same as decided by the engineer-in-charge depending on the exigencies of the work so as to suit the construction schedule.
- 12.2 No Construction equipment shall be supplied by the AAI.

## **13. SITE ORGANISATION**

- 13.1 Subject to the provisions in the tender document and without prejudice to contractors' liabilities and responsibilities to provide adequate qualified and skilled personnel on the work. Contractor shall deploy site organization and augment the same as decided by the engineer-in-charge depending on the exigencies of work. No engineering personnel deployed at site shall be removed from the site without prior approval of the engineer-in-charge.



#### **14. CLOSING DAY'S WORK**

- 14.1 After the closure of day's work, all equipment and stock piled materials must be so placed that after darkness their tops are below a fifty to one ratio from the ends of the basic strips of the runway and twenty to one from sides of useable aircraft traffic areas and must be marked with red flags by day and red lights by night to indicate that they project above the general contour of the aerodrome.
- 14.2 Work shall be closed at 2 hrs. notice for VVIP movement and also other exigencies, if directed by the engineer-in-charge. No compensation shall be entertained on this account from the contractor.

#### **15. LABOUR CAMPS**

- 15.1 No labour camps will be allowed in the operational area/airport premises

#### **16. REGULATIONS**

- 16.1 All men and vehicles will observe the regulations in force in the operational area and will do nothing to pose a danger to the aircraft and their operations. all vehicles will fly the mandatory red flag during day light hours and red lights during night while working in operational areas.

#### **17. INSPECTION OF SITE AND TESTING**

- 17.1 The Engineer-in-Charge or his authorized representative shall have full power to inspect any portion of the work, examine the materials and workmanship at the contractor's works or at any other place from where the material is obtained. Acceptance of any material shall in no way relieve the contractor of his responsibility for meeting the requirement of the specifications.
- 17.2 Routine type tests for the various items of material shall be performed at the contractor's works and test certificates furnished. The contractor shall permit the Engineer-in-Charge or his authorized representative to be present during any of or all the tests. After notification to the Engineer-in-Charge that the work has been completed, the contractor shall make under the direction and in the presence of Engineer-in-Charge such tests and inspections as have been specified or as the Engineer-in-Charge shall consider necessary to determine whether or not the full intent of requirements of the plans and specifications have been fulfilled. In case the work does not meet the full intent of the specifications it shall be rectified by the Contractor at no extra cost and the contractor shall bear all the expenses for any further tests considered necessary.
- 17.3 All tools, instruments, plants and labour/operating personnel for the test shall be provided by the contractor at his own cost.
- 17.4 The Engineer-in-Charge may at his discretion, check the test results obtained at contractors laboratory by independent tests at an approved laboratory. The cost of such material, transport, cost of testing etc. shall be borne by the contractor. Except for routine type tests, all other tests as directed by the Engineer-in-charge shall be



done at the approved laboratory. Testing charges if any shall be borne by the contractor, all other expenditure required to be incurred for asking the samples, conveyance, packing etc. shall also be borne by the contractor.

## **18. ADMISSION TO SITE**

18.1 The airport belongs to AAI. For the works falling within the restricted area, execution shall be restricted to non-office hours. The contractor is expected to finish the work before each break by adequate planning with suitable construction joints etc. as per the satisfaction of engineer-in-charge. All men and vehicles shall be permitted to enter the aerodrome operational area only on possession of the security passes issued by airport- in charge. The contractor shall apply in writing in advance of the commencement of work for issue of security passes and shall submit a list of personnel concerned with their addresses and shall satisfy the engineer-in-charge who shall, at his discretion, have the right to recommend the issue of passes to control the admission of contractor, his agents, his staff and workmen. The contractor shall ensure that his men shall work in areas/zones allotted to them. Passes shall be deposited with the engineer-in-charge on demand and in any case immediately after completion of work. The contractor's staff/workmen shall observe all the rules promulgated from time to time by the concerned authorities such as prohibition of smoking & lighting, search of persons on entry and exit, keeping to specified routes etc. Any person found violating the security rules laid down by the authorities will be expelled from the area without assigning any reason whatsoever and contractor shall have no claim on this account. No time extension shall be granted and nothing extra shall be payable by AAI on account of restricted due to non-operational hours and in restricted working conditions.

## **19. STORES AND MATERIALS**

19.1 No storage accommodation will be arranged by AAI, contractor shall make all such arrangements at his own cost to the satisfaction of engineer-in-charge.

## **20. SITE FOR STACKING OF MATERIALS, MACHINES, INSTALLATIONS OF T&P AND CONSTRUCTION OF TEMPORARY HUTMENTS**

20.1 The contractor shall be allowed to install plants and machineries, store and stack the material within Airport premises in non-operational area. However, installing crushing plant within AAI area will not be permitted. The contractor shall not be permitted to enter on (other than for inspection purpose) or take possession of the site until instructed to do so by the Engineer-in-Charge in writing. The portion of the site to be occupied by the contractor shall be defined and/or marked on the site plan, failing which these shall be indicated by the Engineer-in-Charge at site and the contractor shall on no account be allowed to extend his operations beyond these areas. In respect of any land allotted to the contractor for purpose of or in connection with the contract, the contractor shall be a licensee subject to the following and such other terms and conditions as may be imposed by the licensor:

i) Land/space (Paved / Unpaved/ Covered-AC or Non-AC), to the extent allotted to contractors during execution of the work for the purpose of installation of the plants,



labour camps, cement godown, site office, stacking of materials shall be provided at free of cost up to defect liability period/ maintenance period. A security deposit at the rate of Rs 500/- per sqm in the form of DD/BG shall be deposited by the contractor. In case contractors do not deposit security deposit same shall be deducted from 1st Running Account Bill. Such security deposit shall be released only after allotted land has been fully vacated by the contractor to entire satisfaction of Engineer in charge. If contractor fails to vacate the allotted land / space (paved / unpaved/ Covered -AC/ Non-AC) after Maintenance period of the prevailing license fee of airport plus 25% penalty over that,

ii) That such use or occupation shall not confer any right of tenancy of the land to the contractor.

iii) That the contractor shall be liable to vacate the land on demand by the Engineer-in-Charge.

That the contractor shall have no right to any construction over this land without the written permission of the Engineer-in-Charge. In case, he is allowed to construct any structure he shall have to demolish and clear the same before handing over the completed work unless agreed to the contrary.

20.2 The contractor shall co-operate with any other agency working on the same project, compare plans, specifications and the time schedule and so arrange his work that there will be no interference the contractor shall forward to the engineer-in-charge all correspondence and drawings so exchanged failure to check plans for conditions will render the contractor responsible for bearing the cost of any subsequent change found necessary, contractor should co-ordinate in such a way that on no account there should be any disturbance to the work.

## **21. STANDARD OF WORKMANSHIP**

21.1 To determine the acceptable standard of workmanship, the contractor shall execute portion of the item of work as sample for approval of the engineer-in-charge, before taking up the actual execution of the particular item of work.

## **22. BYE-LAWS**

22.1 The contractor shall comply with all bye-laws and regulations of local and statutory authorities having jurisdiction over the works and shall be responsible for payment of all fees and other charges and for giving and receiving of all necessary notices and keeping the engineer-in-charge, informed of the said compliance with the bye-laws, payments made, notices issued and received.

22.2 The contractor shall indemnify the AAI against all claims in respect of patent rights, design, trademarks of name or other protected rights in respect of any plant, machine, work or materials used for or in connection with the work or temporary works and from and against all claims, demands proceedings, cost, charges and expenses whatsoever in respect of or in relation thereto. the contractor shall defend all actions arising from such claims and shall himself pay all royalties license fees, damages, costs and charges of all and every sort that may be legally incurred in respect thereto.



### **23. SITE PRECAUTIONS**

- i) Any materials or T & P etc. found lying outside the sites approved by the Engineer-in-Charge shall be removed by the Engineer-in-Charge at the risk and cost of the contractor.
- ii) When the contractor's equipment or personnel require to cross areas which are not close to aircraft operations, the contractor shall provide competent flagmen at locations designated by the Engineer-in-Charge to relay signals from airport traffic control to personnel wishing to cross such areas.
- iii) Every transport vehicle shall carry a permit issued by the Chief Authority of Airport/Aerodrome concerned and shall be produced on demand by him or his authorized agent. All vehicles entering the Airport limits shall follow the routes prescribed by the Chief Authority of Airport for entering the areas and shall display red flags on top. No vehicle shall be allowed between sunset and sunrise, also during the day when visibility is 500 metre or less, within the Airport limits where motor vehicle Act does not apply.
- iv) With regard to construction safety measures, the contractor shall adhere to various Indian Standard Codes of Practice, requirements of Provincial Government and local Municipal Authority wherever the provisions of the latter two agencies shall be more stringent than the provisions of the former. When these codes do not exist, the contractor shall adhere to such safety measures as directed by the Engineer-in-Charge.
- v) The contractor shall, during construction, provide barricades at his own cost as per specifications prescribed by the Engineer-in-Charge to segregate the working area to ensure safety of all concerned. The type of barricade is of chain link fencing with proper support or as approved by Engineer-in-Charge.
- vi) The contractor shall be responsible for any damage, resulting from his operations, either to buildings, structures, airport fixtures such as underground cable, contact lights, hard surface areas, water mains, other operational installations, Airport roads etc. The contractor shall restore, replace or repair any such damage to the complete satisfaction of the Engineer-in-Charge and in default the Engineer-in-Charge may cause the same to be made good by any other means and deduct the expenses from any sums due to contractor.
- vii) The work shall be carried out in phases in such a way that there is least obstruction to the office working. The phasing shall be decided by the Engineer-in-Charge, who will be at liberty to change the phasing to suit the requirements. The contractor shall have to abide by these instructions and nothing extra shall be paid to him on this account.
- viii) The work is to be carried out in the airport without causing any hindrance. The construction site area shall be suitably barricaded /cordoned. Notice shall be displayed at site for "work in progress and inconvenience regretted ". The contract shall have to co-ordinate with the aerodrome authorities for plant and machineries



required for execution at site, stacking of material etc. Nothing extra shall be paid to the contractor for all the above.

24. The contractor shall take all precautions to avoid all accidents by exhibiting necessary day & night caution boards, speed limit boards, red flags, red lights and providing barriers. he shall be responsible for all damages and accidents caused due to negligence on his part. No hindrances shall be caused to traffic during execution of work.
25. No payment will be made to the contractor for damage caused by rains or other natural calamities during the execution of the works and no such claim on this account will be entertained.
26. The contractor shall remove the labour huts, temporary barricades etc. on completion of the work and leave the site in a neat and tidy state. The payment of final bill will be subject to the compliance of this condition by the contractor.

**27. MATERIALS AT SITE**

Materials brought to the site by the contractor shall be stored by the contractor in a safe/dry storage space. The contractor shall be responsible for safe custody of materials at site till such time; the installation is commissioned and handed over to the Engineer-in-Charge.

**28. WORK IN RESTRICTED AREA**

The work is to be carried out in restricted area, whenever necessary, the work shall be carried out in the non-operational period. The Contractor shall have to coordinate with the AAI for locating T&P and stacking of materials etc. Nothing extra shall be paid to the Contractor for all the above factors.

**29. TESTING OF MATERIALS**

- 29.1 Mandatory test as prescribed in CPWD specifications shall be conducted for materials that are to be incorporated in the work. For certain tests, which cannot be conducted at site laboratory the same are to be referred to independent laboratory by the Engineer-in-charge. Testing charges, cost of samples including conveyance, packing etc. shall be borne by the contractor.
- 29.2 In case there is any discrepancy in frequency of testing as given in list of mandatory tests and that in individual subheads of works as per CPWD specifications 1991-92 to 2009 the higher of the two frequencies of testing shall be followed, and nothing extra shall be payable to the contractor on this account.

**30. OTHER MISCELLANEOUS FIELD AND LABORATORY APPARATUS**

- 30.1 The contractor or his accredited representative shall be present during sampling / testing and signifying his concurrence for sampling / testing carried out by signing the test records.



- 30.2 The contractor shall be responsible to arrange at his own cost all necessary tools and plants and equipment's required for execution of work.
- 30.3 Necessary manpower for handling, operating and maintaining the above mentioned. Equipment's and machineries shall be provided, by the contractor at his own cost.
- 30.4 Necessary P.O.L required for running the equipment's and machineries deployed for the work shall be provided by the contractor at his own cost. In the event of any breakdown of the equipment's and machineries, the contractor shall take prompt remedial measures to fit them back in condition in the shortest possible time and nothing extra shall be paid for it. To minimize breakdown period, necessary spare parts shall be kept readily available at site by the contractor at his own cost.
- 30.5 The Engineer-in-charge may at his discretion, check the test results obtained at contractor Laboratory by independent test at an approved laboratory. The cost of such material, transport, cost of testing etc. shall be borne by the contractor.

### **31. APPARTITIONING OF WORK**

- 31.1 The Airport Authority of India reserves the right to appartition the work at different levels amongst not more than two contractors, by negotiations if necessary.

### **32. DIFFERENCE BETWEEN FIRST LOWEST BIDDER AND SECOND LOWEST BIDDER.**

- 32.1 The total amount of final bill worked out at the accepted tender rates, if found to be more than the amount worked out at the quoted rates of second lowest, the contractor shall be paid lower of the two.

33. Labour welfare cess shall be levied @ 1% (or as notified) on the gross amount of each running bill and final bill.

### **34. SITE HANDING OVER:**

The site for execution shall be handed over as decided by EIC and no time extension for handing over of site in phases will be granted.

### **35. SCOPE OF THE WORK**

- 35.1 The work under this contract will cover the following types of jobs.

- a) All day to day maintenance and repairing work in respect of the whole Non-operational area including all the structures like residential buildings, offices, drains, water supply and sanitary lines including the other various buildings in non-operational area .
- b) Different original works, renovation works, addition and alterations and maintenance work as and when requires.



- c) Contractor / Agency has to do the work at any of minimum quantum of work/ quantity given to him and complete the same within the time period as given by the EIC at his quoted rate/ percentage and nothing extra over and above the quoted rate shall be payable to him for such work.
- 35.2 This contract being percentage rate contract, the amount of work done may extend to any limit so that the overall value of work executed will be within the limit of award value +30% and contractor shall carry out the work at rate quoted by him during the period of operations of contract and nothing extra over and above the quoted rates shall be payable to him for such works under this contract.
- 35.3 **Period of Contract:** - The period of contract is **24 months** which shall be reckoned **from** 10 day after the date of issue of work order as per work order (acceptance letter) whichever is later. The contract period may also be extended for further period of 6 (**Six**) **months** if needed by AAI on the same terms and conditions of the Contract Agreement with mutual consent of the contractor. AAI reserves the right to terminate the contract wholly or partially by giving 30 days advance notice in writing to the contractor. However performance of contract would be reviewed after every quarter and in case performance is not up to mark found by Engineer-in Charge, the action may be taken as per relevant clause of General Condition of Contract
- 35.4 Different original works, renovation any additional and alteration and maintenance work as and when required shall also be executed through this contract. For any such work of estimated value more than Rs.50,000 contractor shall be intimated separately for each and every work.
- a) All periodical maintenance and special repair/maintenance works exceeding Rs.50,000/- up to 3.00 lakh shall be entered in the register to be specifically maintained for the purpose. The Engineer in-charge or his Authorized Representative shall enter the details of the work to be executed into the register containing columns like serial No., Date of Order, Brief of the work along with items to be executed, approximate cost, time allowed for execution of work with date of start and date of completion, signature of the agency and EIC/Representative.
- b) The time allowed for execution of work shall be reasonable. In case of any disagreement between AGM(C)/SM(C) and Contractor regarding time allowed, the agency shall refer the matter to JGM(C)/DGM(C) within 3 working days, whose decision shall be final. However, the contractor shall continue to work pending decision by JGM(C)/DGM(C) on time allowed to execute the work.
- c) Any delay in execution of work by contractor shall, make him liable for levy of compensation as per relevant clause(s) of contract. However, Engineer in Charge may permit additional time if the work is delayed due to any exigency which is beyond the control of the contractor. The decision of engineer in-charge regarding time and compensation shall be final and binding.



- d) The contractor is supposed to keep adequate manpower and materials to take up any emergency work. Being the airport under operation any such emergency works are to be carried out within the shortest time possible. To meet the emergency situations AAI has the full liberty to bring the other contract agency working in other areas of the same airport to meet the exigency. In this case decision taken by the EIC will be final.
- 36. Excavation:** While carrying out the excavation work the contractor shall carry out the excavation work very carefully assuming that there may be certain power/communication cables and other services like storm water drain, water supply line, chill water pipe line and firefighting line and manholes etc. In case of any damage to the services while carrying out the work, the contractor has to make good the same at his own expenses. Before any excavation work is started with the help of heavy machinery, the contractor shall cut/ open the trench of size approximately 1.00 (w) x 1.00 (D) meters as per direction of Engineer-in-Charge to find out the underground service lines and then only switch over to the excavation with the help of heavy machinery. Nothing extra shall be paid for the same.
- 37.** The rates quoted by the contractor for all the items except those where specific provisions are indicated in the schedule of quantities shall include all leads, lifts, heights and working in or under water and/or liquid mud in or under foul condition, pumping out water caused by springs, tidal or river seepage, broken water mains or drains or due to any other causes. Nothing extra shall be paid on this account.
- 38.** The contractor will remove all the temporary buildings constructed by him such as office/store, as per the clause 8 of special conditions, on completion of the work. The payment of final bill will be subject to the compliance of this condition by the contractor.
- 39.** Ready Mix Concrete can be used for all concrete mixes including RCC and PCC works wherever possible and nothing extra shall be paid in this account.
- 40.** All incidental charges of any kind what so ever including cartage, storage, cutting and wastage etc., shall be borne exclusively by the contractor and nothing extra shall be payable to him on this account.
- 41.** No payment will be made to the contractor for damage caused by rains or other natural calamities during the execution of the works and no such claim on this account will be entertained.
- 42.** The rate for all the items shall unless and until clearly specified otherwise include cost of all the components of labour, material and other inputs involved on the execution of the item.
- 43.** The contractor shall adjust his labour staff, plant, machinery etc. according to the requirement of work from time to time and no claim shall be entertained on account of idle labour, plant, machinery, etc. due to any reason whatsoever.



44. The Contractor /agency should quote the Rate excluding the GST.
45. The Contractor / agency should also quote the Rate excluding the Bonus, EPF & ESI. Bonus, EPF & ESI amount will be reimbursed to the contractor/agency on actual basis on submission of documentary evidence as per prevalent Government Guidelines.
46. Contractor should have valid PF & ESI Registration and GST registration. The relevant documents have to submit by Contractor before award of work.
47. Minimum Wages is considered as on date (Notification No. 1/16(3)/2022-LS-II dated:23.09.2022 by the Chief Labour Commissioner, Gov. of India, New Delhi, W.E.F. 01.10.2022).
48. Changes in increment / decrement in minimum wages done by central Govt. the difference shall be reimbursed/deducted accordingly where minimum wages considered on submission of self-certified documentary proof of having paid the amount to individual employees /deducted from their salary.
49. Contractor has to pay wages though online to the bank account of employees and product the proof of the same. No payment will be done without producing the proof of payment of wages.
50. This contract being percentage contract the amount of work done may be extended to any limit and contractor shall carry out the work at percentage quoted by him during the period of operation of contact and nothing extra over and above the quoted percentage shall be payable to him for such works.
51. The AMC contractor is supposed to keep adequate manpower and material to take up any emergency work. Being the airport under operation any such emergency work is to be carried out within the shortest time possible. In order to have adequate manpower and material AAI desire to keep different contractor under AMC for various areas of Airport, So that different parties will be available to meet the emergency situations with cumulative work force and materials. To meet the emergency situations AAI has full liberty to bring the other AMC contract agency working in the other arears of same airport to meet the exigency. In this case decision taken by EIC will be final.

**52. Entry Pass :**The work site lies in restricted area. The contractor shall apply in writing in advance for issue of necessary entry passes of workmen engaged by him. The office/airport premises are an essential service covered under the maintenance of essential service Act and hence disruption of services rendered will be a statutory offence. The necessary police verification etc. as required for entry passes will be the responsibility of the contractor. All expenditure towards arranging security passes shall be borne by the Agency.

**53. Security Clauses for Agencies working in Operational area :** The contractor and his employees shall abide by security regulation framed by AAI / BCAS or Police Authorities and submit necessary documents through E-Sahaj portal. Any worker of the



contractor whose presence is found undesirable in AAI premises, shall not be allowed to work. The Contractor shall be fully responsible for the satisfactorily working of his staff.

The Contractor shall fulfil the following requirements which are mandatory for obtaining Aerodrome Entry Permits (AEPs) prior to the commencement of operations at Tuticorin Airport:

a. After the award of work the Contractor shall obtain Security Clearance (through E-sahaj portal of Govt. of India/link via BCAS website) for the Company from Bureau of Civil Aviation Security (BCAS) and the copy of the application form should be submitted to EIC at the earliest.

b. The Contractor shall obtain the approval of Entities Security Programme from BCAS.

c. The Contractor shall undertake Police Background Checks of the employees recruited and obtain Police Verification Certificate (PVC) from concerned Police Commissioner in respect of their employees (PVC obtained by the individual prior to the employment is not valid). Background checks shall be conducted at all the places of the applicants residence in the previous one year and of his criminal history, if any. A valid Indian Passport issued in the previous 05 years shall be considered in lieu of background check, provided there is no change in the residential address.

d. After obtaining Police Verification Certificate, the Contractor shall ensure that their employees shall attend one-day AVSEC Awareness Training arranged by the airport operator.

e. Loss of passes shall be intimated immediately by the contractor to the Airport Operations Department who will further inform to concerned RDCOS (CA) BCAS through APSU/ASG and also to the concerned Police Station. It should also be notified to other gates to prevent misuse. BCAS authority will charge penalty prevailing from time to time per token lost and the amount should be deposited immediately and receipt should be obtained. Non-payment and delay will lead to stopping of issuance of further passes.

f. If the contractor is found to violate any of the security regulations, he shall be black listed in addition to being subjected to other legal proceedings.

g. If the work lies in restricted area, operational area and the contractor shall apply in writing in advance of the commencement of work, for the issue of security passes and shall submit a list of the personnel concerned and shall satisfy the Engineer-in-Charge who shall, at his discretion, have the right to recommend the issue of passes to control the admission of the contractor, his agents, his staff and workmen/workwomen. The cost of photographs, if required, for the passes will be borne by the contractor. The contractor shall ensure that his men/women will work in area/ Zones allotted to them. Passes shall be deposited with the Engineer-in-Charge on demand and in any case immediately after completion of work.

h. The contractor, his staff and workmen/workwomen shall observe all the rules promulgated from time to time by the Authority (e.g. prohibition of smoking and lighting, search of persons on entry and exit, keeping to specified routes etc.) Any person found violating the security rules laid down by the Authority will be expelled from the area



without assigning any reason whatsoever and contractor shall have no claim on this account.

i. The Contractor shall ascertain the security and other regulation promulgated at the Airport from time to time and in the event of violation any such regulation he/they should be liable to be debarred from tendering in AAI and subject to other legal proceedings.

j. The agency has to apply for E-bcas registration and upload the Security program via online mode at the earliest after the award of work.

k. The agency has to nominate one Employee for the position of ASCO/CSO from the agency. The Nominated person shall undergo a 5 day Induction Program at ASTI institute as stipulated by BCAS.

**I. NO REIMBURSEMENT OF TRAINING FEES/ANY OTHER TRAINING FEES SHALL BE GIVEN TO THE AGENCY AND AGENCY HAS TO BEAR ALL THE TRAINING COST PERTAINING TO BCAS REGULATIONS.**

m. The Temporary Aerodrome Entry Permit (TAEP) initially for a period of 30 days will be issued by Airport Director, Airports Authority of India (AAI) / respective Airport Operators, with whom the entity entered into written agreement, following the due procedures, to commence business inside the Airport.

n. Immediately thereafter, formalities to comply with the instructions of BCAS i.e obtaining Provisional Security Clearance / Security Clearance through E-sahaj Portal and submission of Security Programme, are to be strictly adhered to. Necessary assistance / guidelines, if required may be obtained from the Airport Operator / BCAS in this regard. The above are mandatory requirements for continuing business in the Airport premises.

o. If the Agency has already obtained Security Clearance for their operations in other region(s), should intimate RO, BCAS, Chennai accordingly duly enclosing the following.

- a) Intimation Letter regarding establishing their business in other Airport,
- b) Security Clearance issued by BCAS, HQ.
- c) Provisional Security Clearance(s) issued by the RO, BCAS, of other region(s).
- d) Written Contract Agreement by the Airport Director
- e) Authorised Signatory for Concerned Airport
- f) Security Programme for concerned Airport.

p. You are requested to strictly comply the above instructions. Failure to comply with any of the above instructions will entail suspension or withdrawal of TAEP/TEP issued.

q. The agency shall arrange the vehicle and driver within their scope of work, without any additional payment.

## **ADDITIONAL SPECIAL CONDITIONS**

### **1. GENERAL**

The following additional special conditions shall be read in conjunction with general condition of contract and amendment / corrections thereto. If there are any provisions in these conditions which are at variance with the provisions in the general conditions, the provisions in these additional special conditions, shall take precedence.

### **2. STORE:**

The contractor shall maintain a minimum of 30 days reserve various stores and Materials in the store-yard. The stores shall be kept in systematic manner and properly stacked as directed by Engineer-in-charge. Necessary chowkidhar and store keeper shall be arranged by the contractor at his own cost for watch and ward and handling of stores.

### **3. MANPOWER:**

The contractor shall deploy a minimum of one qualified full time supervisor (having adequate experience in civil maintenance works) for the supervision of works which are carried out by him and he shall report to the EIC daily. Nothing extra other than the quoted rate shall be paid by AAI in this regard. The supervisor shall inspect the buildings and work sites regularly and arrange timely deployment of manpower and issue of materials. Proper records are to be maintained by him and shall be produced to the Engineer-in-charge or his authorized representative as and when called for.

### **4. RESTRICTED AREA:**

The Work Is to Be Carried out in Restricted Area, so necessary passes Shall be obtained by the contractor for his concerned labourers, supervisors etc., from the concerned authority. No extra payment shall be made by AAI in this regard.

### **5. RESRICTED WORKING HOURS:**

In case normal working hours are reduced due to operational security requirement etc., no extra payment shall be admissible to the contractor but suitable extension of time shall be granted subject to verification of proper records of such restricted working hours maintained at site.

## **6. PERMISSIBLE TIME FOR ATTENDING WORKS:**

- a) Maintenance complaints shall be attended by the Contractor in totality to the entire satisfaction of the Complainer and Engineer-in-charge or his authorized representative within two days of their registration. However, for any emergency work, or providing proper services as water supply, drainage and sewer has to be attended immediately without loss of time. In case the contractor fails to do so the compensation as mentioned in clause 6.4 shall be applicable. The decision of E-I-C or his authorized representative shall be final and binding to the contractor.
- b) All complicated nature of works as so certified by the Engineer-in-charge or his authorized representative shall be attended in totality to the entire satisfaction of the complainer and Engineer-in-charge or his authorized representative within 4 days of their registration.
- c) In case of major break down as so certified by the Engineer-in-charge or his authorized representative, the compliant shall be attended in totality to the entire satisfaction of the complainer and Engineer-in-charge or his authorized representative within 7 days of their registration.
- d) The contractor shall be liable to pay compensation for delay if he fails to meet the conditions as stipulated in paras 6.a, 6.b and 6.c @ Rs.500/- Rs.200/- and Rs.100/- respectively per compliant per day.
- e) In case of emergency the works may have to be completed within the time specified by Engineer-in-charge (after written instruction in the compliant register). In such situation contractor has to mobilize the men and machinery so as to complete the task within the stipulated time. In case of failure Engineer-in-charge shall execute the work as the situation demands to meet the emergency either departmentally or by engaging other agency and the excess cost whatsoever incurred over the original contractor's quoted rate shall be recovered from him.
- f) For the works mentioned in para 2.1 (b) of additional particular specification, in case of any delay compensation will be levied as per the relevant clause stipulated in the general terms and conditions of tender. Decision of Engineer-in-charge and his authorized representative is final and binding to the contractor.

## **7. ORDER FOR EXECUTING WORKS:**

For ordering the various works on the contractor, a register of compliant / works shall be maintained at site at an appropriate location as directed by the Engineer-in-charge. Any day to day maintenance compliant, registered in this register by any resident of AAI quarters or by any AAI employee of the station / aerodrome shall be attended and completed by the Contractor within the time schedule stipulated in condition above. For other maintenance / repair works or any other works within scope of this contract, description of each work along with the stipulated time of completion shall be treed in the register of compliant / work by the Engineer-in-charge or his authorized representative. The contractor shall see the register every day and sign the same as a token of having received the work order.

## **8. LIASON WITH LOCAL BODIES:**

It will be the responsibility of the contractor to liaise with the local bodies like electricity Board / authority, water supply / sanitation / authority, Horticulture Department, Dog Animal squads etc. to get the emergency service attended immediately by the concerned agency at no extra cost.

## **9. POWER:**

Necessary meter and connection from the source as approved by Engineer-in-charge shall be arranged by the Contractor. No extra payment towards meter and connection arrangement shall be paid by AAI.

Wherever AAI electricity source is used by the contractor. Rs.1/-(one) per unit of meter reading or the charge as fixed by the local Electricity Board/Authority whichever is higher shall be recovered from the contractor from the running /final bill.

## **10. REDUCED RATE PAYMENT:**

All works have to be carried out strictly as per standard contract specification and the drawings applicable to the contract. Any work found below specification and not as per the drawing is liable to be rejected. However, if any work is below specification but is technically acceptable as per the discretion of the Engineer-in-charge, the same work will be considered for acceptance and will be paid at a reduced rate at the sole discretion of the Engineer-in-charge, and his decision will be final in this respect and no claim of the contractor shall be entertained in this regard at any stage. The decision of the Engineer-in-charge, regarding rejection or acceptance of substandard work and its reduced rate payable shall be beyond the purview of the Arbitration under clause 57 of this contract.

## 11. RECORDING OF MEASUREMENTS

- a) For the purpose of recording measurement for preparing running account bills, the abbreviated nomenclature indicated in the publication “abbreviated nomenclature of items of DSR 21 (Bilingual)” shall be adopted. The abbreviated nomenclature shall be taken to cover all the materials and operations as per the complete nomenclature of the relevant items in the agreement and other relevant specification.
- b) In case of items for which abbreviated nomenclature is not available in the above cited publication and also in case of Extra and substituted items of work for which abbreviated nomenclature is not provided in the agreement the full nomenclature of items shall be reproduced in the measurement of books and bill forms for running account bills:

**12.** The notice of tender shall form part of the contract document. The successful tenderer / contractor on acceptance on his tender by Accepting Authority shall within 15 days from the stipulated date of start of the work sign the contract consisting of Notice Inviting tenders, general conditions of contract, special / additional conditions. General and particular tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence lead thereto.

**13.** The defects liability period will be Twelve (12) months, which will reckon after the certified date of completion of work for all works being executed under this contract except the ‘water proofing works’. The defects liability period for water proofing works will be Five (05) years after the certified date of completion of contract.

**14. Area of Working:** Terminal Building, ATC tower, Fire station, Runway, Taxiway, Apron including other ancillary buildings, compound wall etc. in Operational Area in Tuticorin Airport.

**15.** Necessary Stationery like A4 size, Legal size paper and Registers shall be provided by agency during the execution. In this account, no payment shall be made by AAI.

### **16. Method of Payment**

The Payment of DSR 2023 Items & AMI (except AMI Items 01(a) & 01(b)) shall be regulated as below:

Rate of DSR Items including Additional Miscellaneous Items as per SOQ = X

Rate to be considered for payment (Y) =  $X/1.2127$

For Payment:  $(Y) \times (100 + \text{quoted percentage by the agency})/100$

The applicable GST will be paid extra

## **PARTICULAR SPECIFICATIONS**

### **1.0 GENERAL :**

1.1 The entire work shall be carried out as per CPWD specifications 2019 with upto date correction slips upto the date of opening of tender for civil works and CPWD specifications (Part I Internal) 2019, with upto date correction slips upto the date of opening of tenders for Electrical works, unless otherwise specified in the nomenclature of individual item, or in the particular specifications.

1.2 However, in the event of any discrepancy in the description of any item as given in the schedule of quantities or particular specifications appended with the tender and the specifications relating to the relevant item as per CPWD specifications mentioned above, the former shall prevail.

1.3 For the item not covered under CPWD specifications mentioned above, the work shall be executed as per latest relevant standards / codes published by B.I.S (Formerly ISI) inclusive of all amendments issued thereto or revision thereof, if any up to the date of receipt of tenders.

1.4 In case B.I.S (Formerly ISI) codes / specifications are not available, the decision of the Engineer-In-Charge based on acceptable sound engineering practice and local usage shall be final and binding on the contractor.

1.5 The rates for different items of work shall be for all heights lifts, leads and depths of the building except where otherwise specified in the item of work or in special conditions appended with the tender.

1.6 The work shall be carried out in accordance with the architects drawings and structural drawings. The structural and architectural drawings, shall have to be properly correlated before executing the work. In case of any difference noticed between architectural and structural drawings, final decision, in writing of the Engineer-In-Charge shall be obtained by the contractor. For items, where so required, samples shall be prepared before starting the particular items of work for prior approval of the Engineer-In-Charge and nothing extra shall be payable on this account.

1.7 All materials to be used on works shall bear ISI, certification mark unless otherwise the make specified in the item or special conditions appended with the tender document. In case IS marked materials or the materials mentioned in the tender document are not used due to non-availability, the materials used shall conform to IS code or CPWD specification applicable in this contract.

1.8 In such cases the Engineer-In-Charge shall satisfy himself about the quality of such materials and give his approval in writing. Only articles classified as "First Quality" by the manufacturers shall be used unless otherwise specified. All materials not having ISI marking shall be tested as per provisions of the Mandatory Tests in CPWD specifications and the relevant SI specifications. The Engineer-In-Charge may relax the condition regarding testing if the quantity or materials required for the work is small. For the products bearing ISI certification mark, no further testing is required at site. In all such cases of use of ISI certified materials, proper proof of procurement of materials from authentic manufacturers shall be provided by the contractor to the satisfaction of Engineer-In-Charge.

1.9 Other agencies doing work of electrification, Air conditioning, external services, other building work, horticulture work, etc., for this project will also simultaneously execute the works and the contractor shall afford necessary facilities for the same. The contractor shall leave such necessary holes, openings etc., for laying burying in the work pipes, cables, conduits, clamps, boxes and hooks for fan clamps, etc., as maybe required for electric, sanitary air conditioning, firefighting, PA system, telephone system, CCTV System and nothing extra over the agreement rates shall be paid for the same.

1.10 Unless otherwise specified in the schedule of quantities the rates for all items of work shall be considered as inclusive of pumping out or bailing out water if required for which no extra payment will be made. This will include water encountered from any source such rains, floods, subsoil water being high due to any other cause whatsoever.

1.11 Any cement slurry added over base surface (or) for continuation of concreting for bond is added its cost is deemed to have in built in the item unless otherwise / explicitly stated and nothing extra shall be payable or extra shall be payable or extra cement considered with consumption on this account.

1.12 The rate for all items in which the use of cement is involved is inclusive of charges for curing.

## **2.0 WORKING DRAWINGS :**

2.1 The drawings if any are available in the office of AGM (Engg-Civil), AAI Engineering wing, Tuticorin Airport. Tenders may see the same in the above mentioned office in working hours.

## **3.0 MATERIALS :**

3.1 Water: Water used for construction work shall be clean and reasonable free from Injurious quantities of deleterious materials such as oils, alkali's, salts and vegetable growth. Generally potable water shall be used.

3.2 Cement: Cement used shall be ordinary Portland cement confirming to IS -8112/1979 - Grade 53, Plain Pozzolona Cement.

3.3 Fine Aggregate: Fine aggregate shall either be sand or crushed stone dust. Percentage of deleterious materials shall not more than 6% Maximum quantity of salt as determined shall not be more than 8%. Fine sand shall be conforming to grading zone IV as per IS : 383. Coarse sand shall be clean, sharp, strong angular and composed of hard salacious materials. It shall be conforming to grading zone III as per IS : 383 - 1970.

3.4 Coarse Aggregate: It shall be crushed or broken from hard stone obtained from approved quarry of gravel (either river bed shingle or put gravel). It shall be clean and from dirt and any other foreign matter. However, the total amount of deleterious substances such as coal, lignite, clay, soft fragments, foreign materials and other deleterious materials in the aggregate shall not exceed 5% of its weight.

3.5 Bricks: Bricks shall be common burnt clay building bricks and shall be free from cracks and flaws and nodules of free lime. The bricks shall have a minimum average compressive strength of 100, 75, 50 & 35 kg/cm<sup>2</sup> as specified in the nomenclature of the item. The average water absorption shall not be more than 20% by weight. Dimensional tolerance for bricks shall be +/- 3% for class designation 100 and +/-8% for class designation 75, 50 and 35.

3.6 Galvanized iron Barbed wire provided should weigh minimum 9.38 kg/100 m.

4.1 For proper quality control during the execution of the work the following field tests shall be carried out by the contractor as and when directed by the Engineer-In-Charge.

- a) Sieve analysis for grading of sand.
- b) Test to determine bulking of sand.
- c) Test to determine silt content for sand.
- d) Sieve analysis for grading of coarse aggregate.
- e) Slump test.
- f) 7 days and 28 days compressive strength test for concrete.
- g) Test to determine water absorption of bricks.
- h) Compressive strength test for bricks.
- i) Test to determine dimensional tolerance of bricks.

4.2. The contractor shall provide at his expense all testing equipment and other facilities at the site which may be required for the purpose of carrying out the field tests as mentioned in Para 4.1 and no extra claim in this account shall be entertained by AAI.

## **PARTICULAR SPECIFICATIONS FOR PAINTING WORKS**

### **PAINTING:**

#### **1.1 MATERIALS:**

Paints, Oils, varnish etc., for approved brand and manufacture shall be used. Ready mixed paint as received from the manufacturer without any admixture shall be used. If for any reason, thinning is necessary in case of ready mixed paint, the brand of thinner recommended by the manufacturer or as instructed by the Engineer-In- Charge shall be used.

Approved paints, oil or varnishes shall be brought to the site of work by the contractor in their original containers in sealed condition. The materials shall be brought in at a time in adequate quantities to suffice for the whole work or at least a fortnight's work. The materials shall be kept in the joint custody of the contractor and the Engineer-In-Charge. The empties shall not be removed from the site of work, till the relevant item of work has been completed and permission obtained from the Engineer-In-Charge.

#### **1.2 COMMENCING WORK:**

Painting shall not be started until the Engineer-In-Charge has inspected the items of work to be painted, satisfied himself about their proper quality and given his approval to commence the painting work. Painting of external surface should not be done in adverse weather condition like hail storm and dust storm.

Painting, except the priming cost, shall generally be taken in hand after practically finishing all other builder's work. The room should be thoroughly swept out and the entire building cleaned up, at least one day in advance of the paint work being started.

#### **1.3 PREPARATION OF SURFACE:**

The surface shall be thoroughly cleaned and dusted. All rust, dirt, scales, smoke and grease shall be thoroughly removed before painting is started. The prepared surface shall have received the approval of the Engineer-In-Charge after inspection, before painting is commenced.

#### **1.4 APPLICATION:**

1.4.1 Before pouring into smaller containers for use, the paint shall be thoroughly in its containers, when applying also, the paint shall be continuously stirred in the smaller container so that its consistency is kept uniform.

1.4.2 The painting shall be laid on evenly and smoothly by means of crossing and laying off, the latter in the direction of grain of wood. The crossing and laying off consists of covering the area over with paint, brushing the surface hard for the first time over and then brushing alternately in opposite direction, two or three times and then finally brushing lightly in a direction at right angles to the same. In this process, no brush marks shall be left after the laying off is finished. The full process of crossing and laying off will constitute one coat.

1.4.3 Where so stipulated, the painting shall be done by spraying. Spray machine use maybe a high pressure (small or aperture) type or (b) a low pressure (large air gap) type, depending on the nature and location of work to be carried out. Skilled and experience workmen shall be employed for this class of work. Paints used shall be brought to the requisite consistency by adding a suitable thinner.

1.4.4 Spraying should be done only when dry condition prevails. Each coat shall be allowed to dry out thoroughly and rubbed smooth before the next coat is applied. This should be facilitated by thorough ventilation. Each coat except the last coat shall be lightly rubbed down with sand paper or fine pumice stone and cleaned off dust before the next coat is laid.

1.4.5 No left over paint shall be put back in to the stock line. When not in use, the containers shall be kept properly closed.

1.4.6 No hair marks from the brush or clogging of paint puddles in the corners of panels, angles of moldings etc., shall be left on the work.

1.4.7 In painting doors and windows, the putty round the glass panes must also be painted. But care must be taken to see that no paint stains etc., are left on the glass. Tops of shutters and surfaces in similar hidden locations shall not be left out in painting.

1.4.8 In painting of steel work, special care shall be taken while painting over bolts, nuts, rivets, overlaps etc.

1.49 The additional specifications for primer and other coats of paints shall be as according to the detailed specifications under the respective headings.

### **1.5 BRUSHES AND CONTAINERS**

After work, the brushes shall be completely cleaned of paint and linseed oil by rinsing with turpentine. A brush in which the paint has dried up is ruined and shall on no account used for painting work. The containers when not in use, shall be kept closed and free from air so that paint does not thicken and also shall be kept safe from dust. When the paint has been used, the containers shall be washed with turpentine and wiped dry with soft clean cloth, so that they are clean and can be used again.

### **1.6 PRECAUTIONS:**

All furniture's, fixtures, glazing, floor etc., shall be protected by covering and stains, smears, splashing, if any shall be removed and any damage done shall be made good by the contractor at his cost.
